Review of LRASP

Dr. Richard Pfau, Associate Dean of the College of Arts and Sciences, presented a status report from the Long Range Academic Systems Plan Committee. He noted that the committee was in the process of revising its recommendations in the light of faculty responses to its draft proposals. The committee's report to the President and Provost is due November 6.

#84004(B) - Establishment of Facilities and Planning Committee

The proposal to establish a permanent Senate Facilities and Planning Committee was presented by the Vice Chairman and Chairman. The committee would expand upon and regularize the function of the current Ad Hoc Master Plan Review Committee. The motion carried.

#84005(D) - Relationship Between the Senate and School Faculties

The Vice Chairman spoke briefly to this resolution, aimed at facilitating communication between the Senate and school faculties. It was agreed to alter the phrase "his designee" to "other Senate representative." The motion carried.

#84006(A) - Amendments to Faculty Charter, Sections 12.1 and 12.4

The Vice Chairman and Chairman spoke to proposed amendments to the Faculty Charter which would eliminate the mandatory review of new faculty for reappointment and promotion during their first year of service. After discussion it was moved by Dr. Yacoub, seconded by Dr. Rubin, to refer the legislation back to the Senate Council. The motion carried.

Disposition of the Report of the Ad Hoc Fact-finding Committee in the Matter of Richard Sharvy (Anderson Report)

Dr. William Betsch, Department of Art and Art History, spoke to his request that the disposition of the Report of the Ad Hoc Fact-finding Committee in the Matter of Richard Sharvy be reconsidered by the Senate Council. It was moved by Dr. Alexandrakis, seconded by Dr. Swan, to refer the matter to the Senate Council and to request that the Council report its recommendations to the Senate at its next meeting. After discussion, the motion carried.
