## II. Implementation

The implementation of the General Education Requirements shall be supervised by a committee chaired by the Provost and composed of the Dean and one faculty member from each of the undergraduate schools and colleges, and including two additional faculty members from the College of Arts and Sciences. The faculty members of the Committee shall be selected by the Senate Council. At the end of two years this transition committee will automatically be replaced by the faculty committee defined below.

The successful implementation of this proposal requires the creation of a standing committee of the University faculty. This committee is described below in Faculty Manual language:

General Education Committee. This committee sets standards for the exemption of required courses and for the certification of the specific courses and course sections which will satisfy the various requirements. The Senate Council shall appoint the Committee and shall include at least one representative from each undergraduate school. Members of the Committee shall serve staggered three-year terms.

The Committee shall create a system of sub-committees whose recommendations are referred back to the General Education Committee for ratification. Each sub-committee shall be chaired by a member of the Committee; the remaining members of the sub-committees need not be members of the Committee.

The General Education Committee shall make an annual report of its activities to the Faculty Senate. At least every five years the General Education Committee shall conduct a review of the General Education Requirements and recommend to the Faculty Senate whatever changes may be appropriate.

## GENERAL EDUCATION REQUIREMENTS

I. Bulletin Language

General Education Requirements

(Effective 1990-91)

The University's General Education Requirements are designed to ensure that graduates of the University have acquired essential intellectual skills and have been introduced to each of the main areas of intellectual achievement. Whereas the requirements of the major specified by Schools and Colleges within the University emphasize depth of learning, these General Education Requirements stress breadth of knowledge and the cultivation of intellectual abilities essential for the acquisition of knowledge. This general knowledge will expand one's understanding of oneself and of the world, enhance appreciation of the artistic and intellectual achievements of the past and present, and help one prepare for an enriched and productive life in the Twenty-first Century.

These requirements may not be satisfied by courses taken "credit only." Upon payment of a recording fee, students may apply the credit hours of any required course from which they are exempted toward the 120 credits required for graduation. The requirements of each School and College at the University are structured so that their satisfaction ensures the satisfaction of the General Education Requirements.

### A. AREAS OF PROFICIENCY

Proficiency requirements are intended to ensure that matriculants either already possess, or will develop at the University, the ability to express themselves effectively, use mathematics with facility, and reason cogently. Superior placement test scores will exempt students from requirements 1 and 2, but not from requirements 3 and 4.

## 1. English Composition

3 credits

ENG 106 [or equivalent course] is required. Entering students are expected to have achieved the level of competence associated with ENG 105. Students who do not meet this expectation are required to enroll in ENG 105. Some students are required to take the remedial course ENG 103. Exemption from 106 or placement in prerequisite courses is based on the CEEB AP examination or on an examination administered by the Department of English during Orientation.

#### 2. Mathematics

3 credits

Students satisfy this requirement by taking a course in mathematics numbered above MTH 101 (excluding MTH 119, 121, and 199), or MAS 110, or an approved course in statistics. Entering students are expected to have achieved the level of competence associated with MTH 101. Students who do not meet this expectation are required to enroll in MTH 101. Some students are required to take the remedial course MTH 199. Exemption from the mathematics requirement or placement in prerequisite courses is based on any of the following tests: CEEB Achievement, AP, or an examination administered by the Department of Mathematics during Orientation.<sup>2</sup>

Requirement three may not be waived. Courses satisfying this requirement are identified in the course schedule by a one-letter abbreviation (shown below within parentheses) following the course number. Some courses satisfying requirement three will simultaneously satisfy an Area of Knowledge Requirement.

# 3. Writing across the Curriculum (W)

12 credits (1990-1995) 15 credits (Fall, 1995)

Each writing course involves a substantial amount of writing and the preparation of papers that are corrected for grammar, style, and content.

aStudents in the School of Music may satisfy this requirement by taking MTH 101. This special provision expires in 1995.

bIn the College of Engineering this requirement is to be satisfied by completing 6 credits with W courses within the Humanities and Social Sciences distribution requirements with the remainder satisfied by writing within the engineering design and laboratory courses.

#### B. AREAS OF KNOWLEDGE

These four requirements are designed to help students understand and appreciate the intellectual achievements in the major areas of human inquiry and creative endeavor. In satisfying these requirements students will explore the natural world, examine human development and behavior, and appreciate creative expression in the arts, literature, and philosophy. Courses satisfying these requirements are identified in this Bulletin, and in the course schedule, by a one-letter abbreviation (shown below within parentheses) following the course number.<sup>C</sup>

1.	Natural Sciences (N)	6 credits
2.	Social Sciences (S)	6 credits
3.	Arts (A)	6 credits
4.	Humanities (H)	6 credits

cIn the College of Engineering, because accreditation requirements do not permit most arts courses to be counted, there will be a general requirement for 18 hours in the Humanities and Social Sciences. In the School of Music, the curricula of individual programs will be submitted to the General Education Committee showing how the areas of knowledge requirements are to be met.

Implementation Committee for General Education Requirements

Until the November meeting of the Faculty Senate, when minutes of the September 11 meeting were distributed, I had not learned of the Senate Council's intention to recommend "withdrawal of the general education requirements legislation under the condition described." The following discussion troubled me. It still does on reflection.

In reviewing the history of this proposal, I am reminded that there were various reasons for the delays, primarily in recent months issues of "governance." Frankly, I do not understand why these have bubbled so hotly to the surface.

Since the meeting, I have reread the entire general education requirements legislation carefully. As you know, I sought the advice of our deans just before Christmas. I do believe that implementation of the new standards will present a mixture of questions, some purely academic and therefore largely the province of the faculty, others administrative and largely the province of others, especially deans. The provost's recommendation for a joint faculty/ administrative committee seems entirely reasonable to me, as does his suggestion that we not decide on the best way to proceed two years hence before we have had any experience with these new requirements. It may well be that a purely faculty committee will prove appropriate after some experience, but it may not. Why we should tie our hands now with a decision based on a new system that we do not yet understand, I fail to understand.

I have decided, nevertheless, to approve this legislation. Instead of bickering about who should be on what committee, we should rather spend our time thinking about how we can best educate our students. Once again, issues of "turf," "process," "governance," "power," etc., have preoccupied us for a long time. We do not have time to waste.

I am among many who believe that we should be thinking far more deeply about our curriculum than these general proposals reflect. Please recall that the freshman experience committee and the Gokel committee are charged with doing just that. They will be reporting shortly.

the Faculty Senate with a recommendation for approval. The motion carried with one opposed.

Dean Perry made a preliminary report on the current status of enrollments at the University. She stated that the freshman class will be underenrolled compared to the number in the Strategic Plan, although the quality will be the best ever. Current projections indicate that transfer students will be close to the budgeted figure and continuing student retention looks favorable.

## Proposed Undergraduate Major in International Studies

Dean David Wilson presented the proposal for an undergraduate major in International Studies in the College of Arts and Sciences. He indicated that the major will be offered only as a second major and will consist of twenty-four credits plus twelve credits of a foreign language. He mentioned that other schools will be cooperating in offering courses and the oversight committee will be composed of faculty from several schools. It was suggested that a hard science person be added to the oversight committee. It was moved by Professor Clasby, seconded by Professor Boardman to forward the proposal to the Faculty Senate with a recommendation for approval. The motion carried with one opposed.

A question was raised with regard to the Graduate School of International Studies offering undergraduate courses through the Honors Program during the current semester. It was noted that this would appear to be in conflict with the charter of the School. The Chairman was asked to look into the matter and report back to the Senate Council. It was suggested that the Chairman inquire about the status of the University Curriculum Committee and to report back to the Senate Council.

## Sale of Complimentary Textbooks

Professor Peter Muller presented matters associated with the sale of complimentary books and noted that the issue is one emerging at the national level. He pointed out that the University of Miami might take a leadership role in this issue. Following discussion, Professor Swan requested that additional material be circulated to the Council members before any action is taken by the Senate.

# Implementation Committee for General Education Requirements

The Chairman summarized the Administration's concept of the transitional committee which would include the undergraduate Deans and faculty representation from the different schools. It was moved by Professor Swan, seconded by Professor Carlebach, to recommend to the Senate that the implementation of the General Education Requirements be vested in a committee chaired by the Provost with the Deans and one faculty member from each of the undergraduate schools and colleges, three faculty members from the College of Arts and Sciences, that the faculty members shall be selected by the Senate Council, and that at the end of two years the transition committee will automatically be substituted by a faculty committee. The motion carried with one abstention.

## Committee On General Education Requirements

The discussion focused on the formation of the General Education Requirements Committee. The Senate felt that the Committee should be a faculty committee and not a Provost's committee. A motion was made to have the Faculty Senate constitute its own committee to study the undergraduate curriculum. An amendment to the motion was then offered to instruct the Chairman and Vice Chairman to represent to the President the dismay of the body on the manner of the appointment of this committee and that this committee must be reconstituted or replaced.

The meeting was adjourned at 4:45 P.M.

Faculty Senate Legislation #89003(B) - Implementation Committee for General Education Requirements

The implementation of the General Education Requirements shall be supervised by a committee chaired by the Provost and composed of the Dean and one faculty member from each of the undergraduate schools and colleges, and including two additional faculty members from the College of Arts and Sciences. The faculty members of the Committee shall be selected by the Senate Council. At the end of two years this transition committee will automatically be replaced by a faculty committee.
