
All approved programs shall pay not less than 8.75% of base nine-month academic salary per three-credit course that is taught as an overload during the academic year or taught during summer session or intersession.

This University is too large, complex, and varied for such central mandates. There are too many variables. What is "overtime," for example, is far from clear in many cases. The system of fair, reasonable negotiation between a department chairman or dean and a faculty member has served us well.
