ACADEMIC BANKRUPTCY

Students entering college sometimes perform at an unacceptable academic level. They either drop out or are dismissed. Some individuals with this experience re-evaluate their educational goals and desire to return to college. Their academic record, however, may present an insurmountable obstacle.

Undergraduate students in this category who want the opportunity for a fresh start at the University without this handicap may apply for initial admission or readmission with the request that their prior academic record be disregarded.

APPLICATION FOR INITIAL ADMISSION TO THE UNIVERSITY WITH ACADEMIC BANKRUPTCY

The applicant must apply to the Office of Admissions and:

- 1. must have been admissible to the University as a senior in high school,
- 2. must have attended an accredited institution for at least one year and must not have attended any college or university for the preceding six months, and,
- 3. must not be admissible to the University based on his or her college-level work.

APPLICATION FOR READMISSION TO THE UNIVERSITY WITH ACADEMIC BANKRUPTCY

A University of Miami student who has dropped out or who has been dismissed may request Academic Bankruptcy on meeting these conditions:

- 1. The student must apply to the Office of the Registrar.
- 2. At least six months must have elapsed since the end of the semester in which the student was last in attendance at the University of Miami.
- 3. Detailed written evidence must be presented to the school in which reacceptance is sought, showing that the conditions or factors that caused the poor performance have changed sufficiently so that there is a reasonable expectation of future satisfactory performance.

CONDITIONS OF APPROVAL

- 1. If Academic Bankruptcy is approved for initial admission, no course credits earned previously will be displayed on the transcript for credits attempted, credits earned, or quality points earned; however, all grades earned previously will remain on the transcript. This condition also applies to readmission applicants, with the exception noted in 2, below.
- 2. Readmission applicants with approval from the dean of the accepting school, may have Academic Bankruptcy apply only to those credits taken by the student when last in attendance at the University of Miami, so that credits earned at another institution subsequent to the date the student last attended the University are not affected.
- 3. Academic Bankruptcy can be granted only once for any student.

FACULTY SENATE MEETING

AUGUST 28, 1995

Chairman's Remarks

Dr. Yacoub, Chair of the Faculty Senate, called the first meeting of the year to order at 3:10 p.m. He recapped the activities of the Senate Retreat held on August 26 at the RSMAS campus. At the conclusion of the Retreat, it was agreed that issues on which a consensus was reached would be incorporated into a strategic plan. The Chair reminded the Senators to send their suggestions and ideas to the Senate office. The plan will be presented to the Senate at a future date.

The Chair announced that the President has signed the following legislation since the April Senate meeting: 1) Name Change for the International Comparative Studies Program to the Undergraduate Program in International Studies; 2) Administrative Appointments and Voting Rights, binding on future appointments; and 3) Academic Bankruptcy - revision of the Bulletin language. The Senate also passed two pieces of "D" legislation which do not require the President's signature: 1) Resolution on the Academic Standards Committee re retention; and 2) Changes in the DF15 Form regarding votes on progress towards tenure. Dr. Yacoub stated that the legislation on sexual harassment was approved by the Senate on April 24 but is still unsigned.

Dr. Yacoub closed his remarks by announcing that he will not seek re-election next April. He urged those interested in seeking the chairmanship to be aware of the amount of time required for the position and the need to keep their schedules for next year flexible.

President's Remarks

The President expressed his appreciation to Dr. Yacoub for his many services to the University culminating with his leadership of the Senate during the past two years. He said he was looking forward to the coming year and welcomed the Senators back from the summer vacation. The President reported that applications for this fall semester were ahead of the previous year and the enrollment numbers appear to be on budget. He announced that the University had raised \$67.8 last year putting us at #19 of private colleges and universities in the United States. He also announced that NIH funding has increased; the effort to cap indirect overhead reimbursements is over; the cap on tax-exempt bond financing is being dropped. Dr. Alexander McIntire, Assistant Dean of the Graduate School of International Studies has been appointed Assistant Provost. His responsibility, among others, will be to restructure and improve advising. Following a nationwide search, Dr. John Clarkson, Chairman of the Department of Ophthalmology and head of Bascom Palmer Eye Institute, has been appointed Dean of the School of Medicine. The search for a Dean of the Graduate School of International Studies has been on

In order to apply for this exception:

1. 2. A University of Miami student seeking readmission to the University should apply to the Office of Enrollment Services; at least six months must have elapsed since the end of the semester in which the student was last in attendance at

As part of the admission or readmission application, the applicant must present to the dean of the school in which the student is seeking acceptance written, detailed evidence that the conditions and/or factors that caused the prior poor performance have changed sufficiently so that there is a reasonable expectation that the student can perform satisfactorily in his or her college career.

If Academic Bankruptcy is approved, no course credit earned previously at any college or university will be displayed on the transcript for credits attempted, credits earned, or quality points earned from the prior academic record; however, all grades earned previously will remain on the transcript. An applicant for readmission to the University, if the dean of the accepting school agrees, may designate that Academic Bankruptcy shall apply to only those credits earned prior to the date the student was last in attendance at the University of Mlami. Academic Bankruptcy will be granted only once during a student's university career.

NOTE: This change is being recommended because: (1) The University does not accept course credit of C- or lower from other institutions; (2) The last paragraph of the current Bulletin description is unclear.
