The Center's efforts are organized as five overlapping sets of projects. Research drives the entire enterprise and forms the centerpiece for all of the activities of CRSS.

- (1) Research and Publication. The Center's research program is designed to focus on important issues pertaining to the relationship of sport to culture, life-course, and human development. Center researchers have been awarded a three-year research grant, titled "Athletic Investment, Academic Promise: How Participation in School Sport May Foster Academic Resilience and Investment Among At-Risk Students," from the U.S. Department of Education, Office of Educational Research and Improvement. The principal investigators are sociologists Jomills Henry Braddock II, Marvin Dawkins, and Joan Alway.
- (2) Coordinated Academic Curriculum. This aspect of the Center's activities is designed to provide students and faculty with enriched learning opportunities and professional development. Efforts will

center on the creation of learning communities, an interdisciplinary, minor concentration, and an interdisciplinary specialization for graduate students participating in masters' and doctoral programs in traditional departments. The Center's research projects will provide an excellent opportunity for the training of graduate students in basic research and program evaluation.

- (3) University/Community Collaborations. The Center will be instrumental in studying community-based projects that emphasize athletic activity and in providing formative and summative evaluation expertise. The Center's staff has the capacity to provide technical assistance to help individuals develop and implement the systematic evaluation of their projects in order to refine their programs.
- (4) Dissemination. An ongoing activity of the Center will be the dissemination of findings and other information derived from the Center's research and development activities. Specifically, the Center will host major national conferences, inviting other researchers and practitioners with a commitment to issues related to sport, culture, life-course, and human development. school. The Chairs should also receive copies of the report, to be shared with their faculties. The Senate Office will also maintain a copy of the report. Since the Academic Affairs Committee of the Board has had its last meeting for the year, Professor Wilson suggested that the Board members receive the material, and then during the fall the Committee could entertain questions from the Board concerning the information. He also suggested that Dean Orehovec and the Senate Academic Standards Committee should make a joint presentation to the Board of Trustees to discuss the data and goals mutually agreed upon between the Faculty Senate and the administration. Provost Glaser commented that the number of inquiries and applications have increased significantly over the past two years. Last year the Senate's Academic Standards Committee recommended that SAT scores should be increased by ten points. accomplished and the University is committed to continue that increase during the next year, according to Provost Glaser. He stated that high school class rank has increased and the SAT scores have remained flat for a period of time. He cautioned that the SAT scores of minority students tend to be lower that those of other students and need to be interpreted according to the group being evaluated. It was moved and seconded to accept the report. The motion carried.

#### Approval of the Name for the Center for Research on Sports in Society

The Chair informed the Senate that the Arts and Sciences faculty has approved the proposed name for the Center for Research on Sports in Society. It had been ascertained that this Center is not the kind with appointed faculty. There being no further comment from the Senate, it was moved and seconded to approve the name. The motion carried. Professor Wilson said that the administration is interested in revisiting the issue of centers as presently defined, probably next fall.

#### Change of Name and Status of the Advanced Diploma in Performance

The Chair introduced Associate Dean David Boyle, School of Music, to give the history of the Advanced Diploma in Performance. The proposal had received the approval of the School of Music department chairs, the School of Music Council, and the Graduate School Council. It was moved and seconded to approve the proposal. The motion carried.

#### Report from the Calendar Committee (First Reading)

Professor Yacoub presented the Calendar Committee's report and recommended scheduling a two-day break during fall 1999. He explained that such things as teaching days, reading days, finals, holidays, opening of the dorms, and the break between semesters were all taken into consideration when planning the new break. Discussion followed. It was suggested that the information should be shared with colleagues in preparation for a vote on May 4. The Provost spoke in favor of interspersing exam days with reading days in an effort to help the students better prepare for their exams.



We are in the process of preparing to request the approval of the Faculty Senate at their March 30 meeting (Bylaw 6.6, page 25 of the Faculty Manual). Jomills Braddock, chair of our sociology department will be the director of the Center. You may have heard from Jomills about the Center or you may have seen some materials about the Center as Jomills has launched a lecture series on issues related to sport in society.

I am writing to you to see if you have any concerns that need to be addressed. I know your schools both offer programs which are somehow related to sports. CRSS will house research/academic programs on sport as a social institution and will not have programs that involve sport performance or management. I have attached a copy of a preliminary brochure about CRSS. I do not believe CRSS will be in conflict with programs in your schools

#### Bachelor of Science in Information Technology (First Reading)

Professor John Stewart, Chair of the Ad Hoc Review Committee, reported on the committee's investigation of the proposal for the Bachelor of Science in Information degree, and its subsequent approval. He mentioned that the proposal combines electrical engineering with basic computer courses, with a strong emphasis on the computer end. Deans Subbaswamy and Temares have discussed the details of the program. The Committee recommended approval of the program. It was suggested that before the second reading, a resolution of the remaining issues between Computer Engineering and Computer Science should be in place. If an impasse exists, a written document should be prepared for discussion with both deans at the Senate meeting. The second reading will be scheduled when the committee is ready. Professor Oxman asked for reaction to the proposal from the relevant faculty, not just the chairs.

It was suggested that when proposals are brought forward for Senate discussion in the future, the relevant faculty should be notified.

#### Report from the Distinguished Faculty Scholar Committee


Professors Frank Millero, former Distinguished Faculty Scholar, presented the Committee's report and recommendation that Professor J. Maxwell McKenzie, Chairman Emeritus of the Department of Medicine, be awarded the 1998 award. The Senate unanimously approved the recommendation.

#### Proposed Center for Research on Sports in Society

The Chair indicated that a request would be forthcoming from the College of Arts and Sciences for Senate approval of the name for a proposed Center for Research on Sports in Society. Professor Wilson explained that the Faculty Manual defines an Independent Center and an Institute or Sponsored Center. It appears that the proposed Center falls into the second category, Section B6.6, of the Faculty Manual. One Arts and Sciences Senator stated that most of the faculty of the College does not know of the existence of such a program and that the information should be circulated. Professor McKenry noted that the School of Education has a similarly named program and that any possible conflict should be considered. It was pointed out that the faculty of the College of Arts and Sciences need to approve the new Center, and that information about the Center should not have been distributed prior to the approvals of the faculty, Senate, and President.

# Taken by the Executive Committee University of Miami Board of Trustees November 17, 1998

AUTHORIZED administration to spend an additional \$300,000 for the completion of the 50% construction documents for the Batchelor Children's Center.

APPROVED amendments to the Faculty Charter regarding: Revisions to Undergraduate Honor Code; Rescission of Section B8 of the Bylaws, pertaining to Graduate School of International Studies; Establishment of the School of International Studies; Establishment of a Department of Geography in the School of International Studies; Transfer of the International Studies Program from the College of Arts and Sciences to the School of International Studies; Restructuring the Honors Program; Establishment of the Bachelor of Science in Information Technology Degree; Approval of the Center for Research on Sport in Society; Change in name for the Department of Geography, and Change in name and status of the "Advanced Diploma in Performance".

**AUTHORIZED** administration to enter into a contract with UNUM for long term care starting in 1999, with the understanding that full premium cost will be covered by faculty and staff.

APPROVED the establishment of the quasi-endowment fund for the School of Continuing Studies.

AFFIRMED and reaffirmed the sense of the Executive Committee that it supports President Foote's recommendation to grandfather current employees to retain tuition remission and that the administration should respect Faculty Senate's processes in regards to tuition remission.
