SUBJECT: Faculty Senate Legislation #99019 (A)- Amendment to Faculty Senate
Legislation #96009(A) - Definition of Educator Faculty

The Faculty Senate, at its meeting of 29 March 2000, voted to approve Faculty Senate
Legislation #99019 (A) - Amendment to Faculty Senate Legislation #96009 (A) - Definition of
Educator Faculty which appears in the Faculty Manual Charter section A2.1(e).

This amendment broadens the notion of Educator Faculty to professionals in addition to
clinicians in the Schools of Medicine and Nursing. The entire section as revised by this
amendment would now read as follows:

The EDUCATOR FACULTY shall consist of those faculty engaged
primarily in professional practice and in teaching associated with that
practice, such as licensed health practitioners with terminal doctoral
degrees and physicians who are in the clinical departments of the School
of Medicine or nurses in the clinical programs of the School of Nursing
with titles [rank] of Clinical [department], (e.g., Professor of Clinical
Surgery or Professor of Clinical Nursing). School faculties, on the
recommendation of the faculty of the department concerned, may also
propose to the Faculty Senate the creation of EDUCATOR FACULTY
positions: Proposals to be considered by the Senate shall define these
positions by department and shall include for each department the
descriptive modified professorial title, the requisite qualifications and
duties that identify the professional practice, and a cap on such positions,
specified either by number or as a proportion of all UNIVERSITY
FACULTY in that department. EDUCATOR FACULTY are full-time but
shall not hold tenured or tenure-earning appointments.

This legislation is now forwarded to you for your action. Should you approve, we will
forward it to the faculty for its vote as an amendment to the Charter section of the Faculty
Manual.


