The Faculty Senate, at its 25 April 2001 meeting, voted unanimously to approve the creation of Educator Faculty positions in the School of Architecture with titles of [rank] Professor in Practice of Architecture. The number of Faculty in Practice shall not exceed one-quarter (1/4) of the number of University Faculty. Nor shall the number exceed (1/3) of the Regular Faculty. The full description is attached for your review.

PROPOSAL FOR THE ESTABLISHMENT OF EDUCATOR FACULTY IN THE SCHOOL OF ARCHITECTURE

The School of Architecture has adopted the following policy, subject to the approval of the Faculty Senate:

The School of Architecture shall have the following titles for Educator Faculty:

Assistant Professor in Practice of Architecture

Associate Professor in Practice of Architecture

Professor in Practice of Architecture

The faculty of the School of Architecture have approved for the School By-Laws the following descriptions and limit on these positions:

2.4 Special to the School shall be Associated Faculty with the title Professor in Practice, Associate Professor in Practice or Assistant Professor in Practice. These titles are granted to full-time faculty who choose to concentrate on practice and its use as a teaching tool. Faculty with these titles shall not hold tenured or tenure-earning appointments. The total number of Associated Faculty with the title "in Practice" shall not exceed one-third of the number of Regular Faculty. Qualifications for "in Practice" faculty members are parallel to the tenured and tenure earning faculty with an emphasis on excellence in professional practice. Bylaws of the School of Architecture

Policy on the Hiring and Retention of Educator Faculty in the School of Architecture

- A) The titles of the positions shall be: Assistant Professor in Practice of Architecture, Associate Professor in Practice of Architecture and Professor in Practice of Architecture. These positions are for faculty whose primary teaching responsibility is in the School of Architecture.
- B) Faculty In Practice will be reviewed annually for accomplishments in teaching, scholarly and creative activities and service according to the standards set forth in the school's *Reappointment, Promotion and Tenure Criteria*. The *Criteria* defines each of the three areas: teaching, scholarly and creative activities and service. The description of each is elaborated with examples and the evaluative criteria are enumerated.
A copy of the *Reappointment, Promotion and Tenure Criteria* is available at the Faculty Senate office.
- C) Faculty in Practice shall be eligible to serve on faculty committees, and vote at faculty meetings to the extent permitted by the Faculty Manual section A3.1c and the *Bylaws of the School of Architecture*.
The *Bylaws* establish a School Council consisting of the Regular Faculty which is vested with the authority and responsibility of the School Faculty as defined in the Faculty Manual. The council may extend to Educator Faculty membership of the council on an annual basis.

- D) The number of Faculty in Practice of the School of Architecture shall not exceed one-quarter (1/4) of the number of University Faculty. Nor shall the number exceed (1/3) of the Regular Faculty.
