## **SUBJECT:** Credit for Laboratory Hours

A faculty member brought an apparent discrepancy between passages in the Undergraduate Bulletin and the *Faculty Manual* to the attention of the Senate, and the Academic Standards Committee was asked to examine the issue and to recommend action as needed.

The passages concern the number of laboratory hours per week that are to be considered equivalent of 1 academic credit. In the Undergraduate Bulletin, under "Academic Credits" – a section that is not by its terms limited to undergraduate courses - it states:

"An academic credit is given for one 50-minute period a week throughout an academic semester. *Two or three* laboratory hours each week throughout a semester are considered the equivalent of one lecture hour in counting credits earned in a laboratory or studio course."

On the other hand, the Faculty Manual, under "Class Periods" says:

"The standard length of a class period during the regular semester is fifty minutes for Monday-Wednesday-Friday classes and one hour and fifteen minutes for Tuesday-Thursday classes. Laboratory periods vary in length and may be *two to four times* as long as a regular class period."

**The Committee first recommends** a slight amendment to the language in the *Faculty Manual* to clarify its applicability. The last sentence of the paragraph in question would then read:

"Laboratory, *performance and clinical* practice periods may be two to four times as long as a regular class period."

The Committee recognizes that there may be circumstances, such as clinical practice periods in the Nursing School's graduate program where it may be desirable for a longer period to correspond to a single academic credit. To this end, **the Committee also recommends** that the following underlined addition be made to the Bulletin:

An academic credit is given for one 50-minute period a week throughout an academic semester. Two or three laboratory hours each week throughout a semester are considered the equivalent of one lecture hour in counting credits earned in an <u>undergraduate</u> laboratory or studio course.
