What is the status of the establishment of the Center for the Study of the Americas?

With the resignation of former Dean James Wyche, all interdisciplinary centers and institutes, including the Center for the Study of the Americas, were placed on hold. In the subsequent two years, there has been no indication from the College of Arts and Sciences or the Provost's Office that there is interest in reviving the project.

Is the CLAS still active?

Absolutely. The CLAS was to be folded into the Center for the Study of the Americas, so when that project was put on hold, the CLAS simply continued to function for the coordination and promotion of Latin American related research and other activities on campus. The Center's on-going efforts in this regard include:

• Interdisciplinary Research Groups that encourage faculty and graduate students to meet and discuss their common research interests with the ultimate goal of stimulating individual and joint research projects. The level of Latin Americanist faculty and graduate student interest in Interdisciplinary Research Groups continues to grow. At the end of the Spring Semester we had seven active groups. Last week was the deadline for applications for funding for continuing and new Groups. We received a record number of applications for 11 Interdisciplinary Research Groups.

- A Speakers Series and other events (i.e., exhibits, musical programs, etc.) See attached listing covering the past two years plus events already confirmed for the fall and spring semesters 2006-2007.
- Three programs of Grants and Prizes for graduate and undergraduate students rewarding academic excellence and supporting research in Latin America. In summer 2006 the center awarded 8 graduate travel research grants, 3 undergraduate awards, and named two Barrett Prize recipients.
- A Visiting Scholars Program involving courtesy appointments for scholars visiting South Florida for extended periods of time who wish to be affiliated with the Center. See attached list.
- Functioning as the home of Latin American Politics and Society, internationally recognized as a top-tier interdisciplinary social science journal focusing on contemporary politics, social change, and international relations in the Americas.

There was a question at the Spring Semester meeting of the General Welfare Committee about the proper designation for the CLAS. Given the scope of its activities, the membership of its Executive Board, participating faculty and graduate students, the Center is truly a University-wide institution. The Executive Board, for example, includes members from the School of Communication, RSMAS, the Law School , the Business School and the Library as well as from the College of Arts and Sciences. Moreover, the major funding source for the CLAS is the Office of the Provost. For reporting purposes, the Director reports to the Dean of the College of Arts and Sciences. See attached a memo from Dean Halleran that addresses this issue.

2. If so, is it on financially sound footing?

During the past two years the CLAS has been functioning with approximately the same budget as in the previous period. While this budget has permitted the Center to maintain its customary level of activities, these resources are not sufficient for the CLAS to respond to the growing campus interest in Latin America as expressed by the expanding numbers of undergraduates and graduates enrolled in Latin American Studies degree programs as well as new faculty hires in the area. Also, the limited funding has been a brake on the CLAS's fulfillment of its longstanding promise to become one of the country's most dynamic centers for the study of the Latin American region. These concerns, shared by the Director and the Executive Board, led to a proposal requesting additional resources for the following:

 Increased funding to Interdisciplinary Research Groups with the goal building ties among faculty of various departments and of providing incentives to seek outside funding.

 Additional Graduate Student Summer Research Grants to respond to the increasing numbers of qualified applicants for these awards.

- The launching of a high-visibility, year-long program of events to focus on the state of the art of core issues and topics for the study of Latin America.
- A Small Grants Faculty Research and Professional Travel program, similar to those offered at peer centers in the U.S., to provide seed money for new research and travel to professional meetings.

At this writing, we are awaiting the decision from the Dean of Arts and Sciences and the Provost on this proposal.

3. Is it achieving its mission and striving for excellence?

The Center continues to strive for excellence as it has since its founding. It does achieve its mission of coordinating and promoting Latin American activities at the University. The present level of support does not, however, permit the CLAS to rise to the level of its potential as one of the elite Latin American centers in the country, or in the words of Provost LeBlanc, to "own Latin America."

October 18, 2006 Faculty Senate minutes

The meeting, held in the Hurricane 100 room in the BankUnited Center, opened at 3:30 p.m.

CHAIR'S REMARKS

In addition to the comments included in his memorandum to Senators, the Chair informed the Senate of several additional items:

- The President responded to the resolution that was passed at the last meeting pertaining to the administration's handling of student discipline regarding the janitors strike, noting that in recognition of that concern she has charged a committee of faculty, students, and staff to review the current procedures and processes and report their recommendations to her.
- Vicky Mitrani, who was a senator from the Miller School of Medicine, has transferred her appointment to the School of Nursing and Health Studies and has been elected as that School's senator.
- The remarks attributed to the Chair in the Sun-Sentinel regarding the FIU/UM football game were a misquote. The Chair stated that he would never presume to speculate on what the Faculty Senate will or will not do in any meeting.

PRESIDENT'S REMARKS

Prior to the President's Remarks, a motion was made and seconded to add a discussion of student disciplinary issues as the first item under General Matters. The Senate voted unanimously to approve the addition. The President stated that she would hold her remarks about the football melee and discipline for that portion of the agenda. She then presented a number of items:

- Every indicator of student quality has gone up at the University, including for example class rank, SAT, LSAT, and MCAT.
- The Provost's recruitment of new University leaders continues to bring extraordinary talent. The appointment of five new distinguished professors also helps to celebrate our commitment to faculty excellence and our understanding that great universities are built on great faculties.
- Dean Goldschmidt's recruitment of faculty and faculty administrators in the Miller School of Medicine has strengthened that school dramatically and is supported by the Miller gift. The gift was not an endowment and not for buildings but to recruit and retain the finest faculty.
- A \$35.6 million gift was received from the estate of the late Eugenia J. Dodson to the Diabetes Research Institute and the Sylvester Comprehensive Cancer Center.
- The Diabetes Research Institute has increased its pledge to the University another \$15 million from \$65 million to \$80 million.
- The Batchelor Foundation has given \$5 million for Pediatrics.
- As promised, the second phase of the momentum campaign focuses on creating endowed chairs across the University both to retain existing faculty and to recruit new faculty.
- The Schecter Family Foundation has donated \$2 million in a specific area of the new University hospital that will be named after them. Money is being raised to name parts of the new hospital that will be used to support faculty.
- Dany and Dwayne "The Rock" Johnson have donated \$2 million to name the living room of the Robert and Judi Prokop Newman Alumni Center. Both are graduates of the University.
- Laurie Silvers committed a total of \$1.6 million for an endowed distinguished professorship in the School of Law.

- Publix Supermarkets Charities have increased their pledge for the George W. Jenkins Scholarships in the School of Business.
- John Roberts, Chief Justice of the United States, will make his first public appearance at the University on November 13 and 14. He will give a public presentation in the BankUnited Center and will be teaching classes in history, communications, and law.
- Dean search committees have been appointed for the Frost School of Music, chaired by Michael Halleran; the School of Business, chaired by William Green; the Graduate School, chaired by Otis Brown; and the School of Engineering, chaired by Richard Bookman.
- At the upcoming Board of Trustees meeting, the major presentation will be on the University Strategic Plan.

The President asked the Provost to make a few remarks:

- The first step of the strategic planning process focuses on the quality of the undergraduate student body and student experience. A number of faculty committees are being formed to review issues that are of importance to the Strategic Plan. William Green, Senior Vice Provost and Dean of Undergraduate Education, is working with the Senate's University Curriculum Committee to evaluate the Honors Program and make recommendations for changes.
- Regarding this year's measurements of student quality, the University received applications from 19,040 students, of whom 40% were accepted. SATs are at 1269, an increase of 11 points over last year; the median is 1280, an increase of 20 points over last year. We now have 14% of the freshman class over 1400 on their SATs and 60% between 1200-1400. For the first time, 8% of our students came from Computed Selectivity Index One, doubling last year's percentage; 35% came from CPI Two and another 35% from CPI Three. Across the board, every statistic is improving. If we continue on this path, we will easily make the five-and ten-year goals that have been previously discussed.

APPROVAL OF AGENDA

The meeting agenda, as amended with a new item B1, namely, student disciplinary matters, dropping all the other items one place, passed unanimously.

APPROVAL OF THE MINUTES OF SEPTEMBER 27, 2006

The minutes of September 27, 2006, passed unanimously.

OTHER ANNOUNCEMENTS

The Chair expressed the apologies of the first Vice Chair, Michael Lewis, for his absence because he was way away on business.

STUDENT DISCIPLINARY MATTERS

President Shalala described in detail the unfortunate events of the UM/FIU football game that took place on Saturday, October 14, 2006. She stated that student athletes are governed by rules of their conference, of the officials on the field, and of their athletic department, all of which are handled relatively quickly. She asserted that the penalties levied include a new standard at UM: If a player gets into a fight on the field, the player will not be able to play for the rest of the season, and possibly never again, depending on the circumstances. The President asked Paul Dee, Director of Athletics, to speak on the discipline process. He first apologized to the Senate, stating that he regretted that the event took place, and then described the actions on the part of the conference and the University in the ensuing 48 hours, noting that the President called a meeting of the senior leadership of the University for the day following the game, in which the

film of the brawl was reviewed again thoroughly. After discussion among the leadership, it was determined that the suspension of the team member involved in the helmet incident was insufficient and that the player would be suspended indefinitely. All of the athletes involved were put on probation and must participate in community service, and other disciplinary measures may be imposed.

The President and Mr. Dee entertained questions from the floor. After discussion, the matter was considered closed and no action was taken by the Senate.

A request was made to return to the topic of the resolution approved by the Senate the previous month regarding the disciplinary actions against the students who participated in the demonstrations pertaining to the janitors strike. Eugene Clasby, Senator from the College of Arts and Sciences, explained his view on the actions taken by the administration. The President stated that she would forward Dr. Clasby's statement to the committee that is reviewing the current discipline procedures and ask them specifically to review whether the fundamental premise underlying our current rules and regulations is flawed. She stated that she welcomes comments and asked that members either e-mail her or make an appointment to meet with her. The Chair of the Senate noted that a good portion of the agenda remained and asked if the body felt that this discussion should continue. No objection was made to moving ahead with the rest of the agenda.

INTRODUCTION OF PASCAL GOLDSCHMIDT, SENIOR VICE PRESIDENT FOR MEDICAL AFFAIRS AND DEAN OF THE MILLER SCHOOL MEDICINE

Unfortunately, because the previous discussion ran long, the Dean had a prior engagement and needed to leave. This item will be rescheduled.

INTRODUCTION OF ISAAC PRILLELTENSKY, DEAN OF THE SCHOOL OF EDUCATION

Dean Prilleltensky shared information on his personal background and explained that his vision for the School is for it to be a center of excellence in multicultural well-being in families, schools, and the community; its mission will be to prepare leaders in the study and promotion of physical, psychological, educational, and social well-being of our increasingly diverse population.

INTRODUCTION OF WILLIAM GREEN, SENIOR VICE PROVOST AND DEAN OF UNDERGRADUATE EDUCATION

Dr. Green shared some personal information, noting that he was with the University of Rochester for 32 years, where he started teaching religion and founded the Department of Religion and Classics and helped to develop a distinctive undergraduate curriculum. His areas of responsibility at the University of Miami have to do with the undergraduate experience, and he will be co-chairing with Michael Gaines the Science, Technology, Engineering, and Mathematics (STEM) Committee that is going to take a comprehensive look at the University's undergraduate programs in all of those areas and make recommendations to the Provost. He will be participating in a working group with Patricia Whitely to review everything that happens with undergraduate students in their first year to see what is successful and to find areas where improvement is needed to improve the student experience. He will also look at new directions we might pursue in terms of global education and study abroad for undergraduates. High on his priority is a thorough review of the University's Honors Program, and he is working with the Senate's University Curriculum Committee, which has agreed to make this issue its primary project for this year. He has had a number of meetings with different student groups, and a review of the Honors Programs has been regularly mentioned as a high priority. He concluded

that he has been especially impressed with the persistence and passion with which the student government has advanced a whole range of educational issue that concern them.

RE-APPROVAL OF THE CENTER FOR LATIN AMERICAN STUDIES

The Chair stated the General Welfare Committee recommended re-approval of the Center for Latin American Studies for five years and asked if there were any questions or comments regarding the <u>proposal</u>. The Senate voted unanimously to re-approve the Center for five years.

FACULTY SALARY COMPARISON REPORT

Rene Sacasas, Chair of the Budget and Compensation Committee for 2005-2006, presented a faculty salary comparison report on last year's figures. He stated that there is not much difference in the figures from those reported last year but that the Provost's office has been very open with the Committee. The Provost has made himself available to the Committee in terms of understanding how the budgetary process works and how it ties into the strategic planning process. The Provost is committed to this process and is encouraging the Committee to participate in the strategic planning process as well as in the budgetary review process. After discussion, the Senate thanked Professor Sacasas for his report.

The remainder of the meeting was held in Executive Session to discuss the James W. McLamore Outstanding Service Award.

The meeting adjourned at 5:25 p.m.

What is the status of the establishment of the Center for the Study of the Americas?

With the resignation of former Dean James Wyche, all interdisciplinary centers and institutes, including the Center for the Study of the Americas, were placed on hold. In the subsequent two years, there has been no indication from the College of Arts and Sciences or the Provost's Office that there is interest in reviving the project.

1. Is the CLAS still active?

Absolutely. The CLAS was to be folded into the Center for the Study of the Americas, so when that project was put on hold, the CLAS simply continued to function for the coordination and promotion of Latin American related research and other activities on campus. The Center's on-going efforts in this regard include:

Interdisciplinary Research Groups that encourage faculty and graduate students to meet and discuss their common research interests with the ultimate goal of stimulating individual and joint research projects. The level of Latin Americanist faculty and graduate student interest in Interdisciplinary Research Groups continues to grow. At the end of the Spring Semester we had seven active groups. Last week was the deadline for applications for funding for continuing and new Groups. We received a record number of applications for 11 Interdisciplinary Research Groups.

- A Speakers Series and other events (i.e., exhibits, musical programs, etc.) See attached listing covering the past two years plus events already confirmed for the fall and spring semesters 2006-2007.
- Three programs of Grants and Prizes for graduate and undergraduate students rewarding academic excellence and supporting research in Latin America. In summer 2006 the center awarded 8 graduate travel research grants, 3 undergraduate awards, and named two Barrett Prize recipients.
- A Visiting Scholars Program involving courtesy appointments for scholars visiting South Florida for extended periods of time who wish to be affiliated with the Center. See attached list.
- Functioning as the home of Latin American Politics and Society, internationally recognized as a top-tier interdisciplinary social science journal focusing on contemporary politics, social change, and international relations in the Americas.

There was a question at the Spring Semester meeting of the General Welfare Committee about the proper designation for the CLAS. Given the scope of its activities, the membership of its Executive Board, participating faculty and graduate students, the Center is truly a University-wide institution. The Executive Board, for example, includes members from the School of Communication, RSMAS, the Law School , the Business School and the Library as well as from the College of Arts and Sciences. Moreover, the major funding source for the CLAS is the Office of the Provost. For reporting purposes, the Director reports to the Dean of the College of Arts and Sciences. See attached a memo from Dean Halleran that addresses this issue.

2. If so, is it on financially sound footing?

During the past two years the CLAS has been functioning with approximately the same budget as in the previous period. While this budget has permitted the Center to maintain its customary level of activities, these resources are not sufficient for the CLAS to respond to the growing campus interest in Latin America as expressed by the expanding numbers of undergraduates and graduates enrolled in Latin American Studies degree programs as well as new faculty hires in the area. Also, the limited funding has been a brake on the CLAS's fulfillment of its longstanding promise to become one of the country's most dynamic centers for the study of the Latin American region. These concerns, shared by the Director and the Executive Board, led to a proposal requesting additional resources for the following:

 Increased funding to Interdisciplinary Research Groups with the goal building ties among faculty of various departments and of providing incentives to seek outside funding.

 Additional Graduate Student Summer Research Grants to respond to the Increasing numbers of qualified applicants for these awards.

- The launching of a high-visibility, year-long program of events to focus on the state of the art of core issues and topics for the study of Latin America.
- A Small Grants Faculty Research and Professional Travel program, similar to those offered at peer centers in the U.S., to provide seed money for new research and travel to professional meetings.

At this writing, we are awaiting the decision from the Dean of Arts and Sciences and the Provost on this proposal.

3. Is it achieving its mission and striving for excellence?

The Center continues to strive for excellence as it has since its founding. It does achieve its mission of coordinating and promoting Latin American activities at the University. The present level of support does not, however, permit the CLAS to rise to the level of its potential as one of the elite Latin American centers in the country, or in the words of Provost LeBianc, to "own Latin America."

What is the status of the establishment of the Center for the Study of the Americas?

With the resignation of former Dean James Wyche, all interdisciplinary centers and institutes, including the Center for the Study of the Americas, were placed on hold. In the subsequent two years, there has been no indication from the College of Arts and Sciences or the Provost's Office that there is interest in reviving the project.

1. Is the CLAS still active?

Absolutely. The CLAS was to be folded into the Center for the Study of the Americas, so when that project was put on hold, the CLAS simply continued to function for the coordination and promotion of Latin American related research and other activities on campus. The Center's on-going efforts in this regard include:

 Interdisciplinary Research Groups that encourage faculty and graduate students to meet and discuss their common research interests with the ultimate goal of stimulating individual and joint research projects. The level of Latin Americanist faculty and graduate student interest in Interdisciplinary Research Groups continues to grow. At the end of the Spring Semester we had seven active groups. Last week was the deadline for applications for funding for continuing and new Groups. We received a record number of applications for 11 Interdisciplinary Research Groups.

- A Speakers Series and other events (i.e., exhibits, musical programs, etc.) See attached listing covering the past two years plus events already confirmed for the fall and spring semesters 2006-2007.
- Three programs of Grants and Prizes for graduate and undergraduate students rewarding academic excellence and supporting research in Latin America. In summer 2006 the center awarded 8 graduate travel research grants, 3 undergraduate awards, and named two Barrett Prize recipients.
- A Visiting Scholars Program involving courtesy appointments for scholars visiting South Florida for extended periods of time who wish to be affiliated with the Center. See attached list.
- Functioning as the home of Latin American Politics and Society, internationally recognized as a top-tier interdisciplinary social science journal focusing on contemporary politics, social change, and international relations in the Americas.

There was a question at the Spring Semester meeting of the General Welfare Committee about the proper designation for the CLAS. Given the scope of its activities, the membership of its Executive Board, participating faculty and graduate students, the Center is truly a University-wide institution. The Executive Board, for example, includes members from the School of Communication, RSMAS, the Law School, the Business School and the Library as well as from the College of Arts and Sciences. Moreover, the major funding source for the CLAS is the Office of the Provost. For reporting purposes, the Director reports to the Dean of the College of Arts and Sciences. See attached a memo from Dean Halleran that addresses this issue.

2. If so, is it on financially sound footing?

During the past two years the CLAS has been functioning with approximately the same budget as in the previous period. While this budget has permitted the Center to maintain its customary level of activities, these resources are not sufficient for the CLAS to respond to the growing campus interest in Latin America as expressed by the expanding numbers of undergraduates and graduates enrolled in Latin American Studies degree programs as well as new faculty hires in the area. Also, the limited funding has been a brake on the CLAS's fulfillment of its longstanding promise to become one of the country's most dynamic centers for the study of the Latin American region. These concerns, shared by the Director and the Executive Board, led to a proposal requesting additional resources for the following:

 Increased funding to Interdisciplinary Research Groups with the goal building ties among faculty of various departments and of providing incentives to seek outside funding.

 Additional Graduate Student Summer Research Grants to respond to the increasing numbers of qualified applicants for these awards.

The launching of a high-visibility, year-long program of events to focus on the state of the art of core issues and topics for the study of Latin America.

 A Small Grants Faculty Research and Professional Travel program, similar to those offered at peer centers in the U.S., to provide seed money for new research and travel to professional meetings.

At this writing, we are awaiting the decision from the Dean of Arts and Sciences and the Provost on this proposal.

3. Is it achieving its mission and striving for excellence?

The Center continues to strive for excellence as it has since its founding. It does achieve its mission of coordinating and promoting Latin American activities at the University. The present level of support does not, however, permit the CLAS to rise to the level of its potential as one of the elite Latin American centers in the country, or in the words of Provost LeBlanc, to "own Latin America."
