

Basis: Established under Section B6.6 of the University of Miami Faculty Manual.

Name: Henry Mancini Institute

Mission:

The Henry Mancini Institute (HMI) provides advanced pre-professional performers, conductors, and composers with intensive instruction and experiences in the broad diversity of music that is encountered in today's musical environment. The instruction in film music, jazz and popular styles, improvisation, world music, electronic performance, digital music applications, and entrepreneurship provided by major guest artists and resident faculty is far beyond that offered by traditional conservatory training.

Objectives:

- The Institute will provide its graduate student fellows with rehearsal, performance, and pedagogical experiences led by renowned artists, composers, and conductors.
- The Institute will focus on music across the genres of classical, jazz, pop, film music, world music, and styles yet to be incubated.
- The Institute student fellows will be organized into the Henry Mancini
 Institute Orchestra and in smaller ensembles appropriate to the music being
 performed.
- The Institute will provide public concerts that feature renowned artists, composers, and conductors who have worked with the graduate student fellows in preparing the performances.
- The Institute will provide master classes and residencies by a diverse array of highly acclaimed artists.
- The Institute's chamber music groups will have extensive involvement in community engagement activities, reaching out to the community and atrisk students.

Background:

Jack Elliott founded the Henry Mancini Institute in 1996 as an academy for young music professionals. The Institute brought together the most talented post-baccalaureate degree young musician professionals in the summer to compose, arrange, and perform a broad array of music that is appealing to the broad spectrum of today's music listeners. Through this experience, musicians learned the skills beyond those of the classical orchestra. That is, the skills necessary to be successful in today's musical world.

The HMI began having financial problems in the early 2000s and was forced to close on December 31, 2006. Dean Shelly Berg of the Frost School of Music has successfully negotiated with the Mancini family to bring the Henry Mancini Institute to the University of Miami. The academy concept has been reworked to focus on the artist-level graduate students of the Frost School of Music.

Staffing:

Artistic Director. The HMI Artistic Director will be appointed for Fall Semester 2009. The Director will lead the Henry Mancini Institute Orchestra in concert and in the final preparations for the concert. Negotiations are currently underway with two renowned artists one of whom is a ten-time Grammy award winner and the other is one of the top ten film composers of all time.

Institute Faculty. The faculty of the Frost School of Music will lead early preparation for Institute performances.

Henry Mancini Fellows. There will be 45 Mancini Fellows who are graduate students enrolled in the academic programs of the Frost School of Music in the areas of instrumental performance, studio music and jazz, and composition.

Guest Artists. Guest artists will be well known and highly regarded individuals who are active in the musical profession. For the 2008-09 academic year these artists will include Steve Miller, Dave Grusin, Bruce Hornsby, Rickey Skaggs, Maria Schneider, Pablo Ziegler, Joshua Redman, Phil Ramone, Anthony Davis, Jon Secada, Dave Koz, Tom Scott, Eric Marienthal, Eddie Palmieri, Will Lee, Monica Mancini, Gregg Field, and John Corigliano.

Coordinator of Activities. A coordinator of HMI activities will be appointed during the 2009-10 academic year. The Coordinator will oversee basic administrative functions and community engagement activities.

Administrative Support. The Frost School of Music will provide administrative support.

Funding:

The Bulk of HMI funding is in place, utilizing existing faculty lines, master class allocations, and teaching and performance spaces. Twenty-one of the 45 Mancini Fellowships will be awarded from existing assistantships in the Frost School. The Artistic Director and Coordinator salaries will be funded from the Frost Naming Endowment.

The Frost School Strategic Plan calls for development activities to fund the remaining TA stipends and to endow the Artistic Director's chair. The marquee value of this institute, named for one of the most beloved composers in U.S. history, will enhance opportunities for fundraising.

Operating Rules:

The Institute will consist of an Artistic Director, an Advisory Committee consisting of Frost School of Music faculty, 45 graduate student fellows, a Coordinator of Activities, and select faculty from the areas of instrumental performance, studio music and jazz, and composition.

- 1. The Dean of the Frost School of Music will appoint the Artistic Director, the Advisory Committee, and the Activities Coordinator.
- 2. The Advisory Committee will meet on a monthly basis to plan and implement the Institute's activities with close consultation with the Institute's Artistic Director. The Advisory Committee will work with Frost School of Music faculty and the Associate Dean of Graduate Studies in the selection of the Institute's graduate student fellows. The Advisory Committee will review and make recommendations on the best use of funds raised to support the Mancini Institute. The Advisory Committee will seek input from Frost School of Music to ensure the efficient operations of the Institute while attaining the highest artistic levels of performance. This will also include hearing and appropriately responding to any issues that might be identified by the faculty. Robert's Rules of Order will govern all meetings.
- 3. The Artistic Director, the Advisory Committee, and the Activities Coordinator report directly to the Dean of the Frost School of Music.

October 29, 2008 Faculty Senate Minutes

The meeting, held in the McLamore Executive Education Center, Jenkins School of Business Administration, opened at 3:32 p.m.

CHAIR'S REMARKS

The Chair highlighted his written remarks and explained that the Provost was ill and will not be able to attend.

PROVOST'S REMARKS

[Provost was out ill today.]

APPROVAL OF TODAY'S AGENDA

The meeting agenda passed unanimously.

APPROVAL OF MINUTES OF August 27, 2008

The minutes of September 24, 2008, passed unanimously.

OHER ANNOUNCEMENTS

The Chair announced the birthday of the First Vice Chair, Sherrill Hayes, followed by a rousing chorus of "Happy Birthday."

DISESTABLISHMENT OF THE PEW INSTITUTE FOR OCEAN SCIENCE

The Chair presented the proposal to disestablish the Pew Institute at the Rosenstiel School of Marine and Atmospheric Sciences, effective December 31, 2008. In response to a question about the reason for the action, Stephen Cantrell explained that the focus of the funding agency has changed.

The proposal passed unanimously.

SUMMARY OF DATA ON MENTORING INFORMATION FROM THE FACULTY SURVEY 2008 - INFORMATION ITEM ONLY

Sherrill Hayes, First Vice Chair, stated that this is a follow-up from last month's Senate meeting, where the Provost gave a general presentation on the faculty survey administered last academic year. She commented specifically on the responses regarding mentoring, noting that those faculty who reported having a mentor were more positive on items throughout the survey than those who did not, even on items that had nothing to do with mentoring itself. More non-tenure track than tenured/tenure track faculty thought a workshop on mentoring would help them achieve their

goals. Overall, the trends were not unique or distinctive between campuses. She reminded the Senate of the task force on mentoring that she chaired several years ago, which also surveyed the faculty on this issue and made recommendations that were approved by the Senate in 2006, specifically requesting funding to set up a more formal mentoring process. There seems to be a global positive sentiment that it is desirable to pursue this matter with the administration.

She entertained questions from the floor.

There was discussion about the process of tracking recommendations once they have been made to the administration, and it was decided that the process will be discussed at the General Welfare Committee meeting.

Dr. David Birnbach, Vice Provost for Faculty Affairs, explained that the administration was looking into a mentoring plan and will bring a draft for discussion to the Senate in January or February 2009 and come back the following month with a report.

PROPOSAL TO CHANGE SCHOOL OF EDUCATION UNDERGRADUATE MAJOR FROM "HUMAN SERVICES" TO "HUMAN AND SOCIAL DEVELOPMENT"

The Chair gave some background information that the major had not attracted students for some time so it was reevaluated and restructured, requiring that the name be changed. The proposal came to the General Welfare Committee, which asked the School of Education to check with the School of Business Administration and the Psychology Department to make sure that there is no detrimental overlap with their programs. Both of those units have signed off on the change. Dean Isaac Prilleltensky and Blain Fowers highlighted the proposal to change the name of the major to broaden its focus and bring in new students who will be interested in working in community settings.

They entertained questions from the floor.

The proposal passed unanimously.

PROPOSAL TO ESTABLISH THE FROST SCHOOL OF MUSIC HENRY MANCINI INSTITUTE

Edward Asmus, Professor, Phillip and Patricia Frost School of Music, summarized the proposal and gave some history about the Mancini Institute, which had been in California. Mrs. Mancini wanted to move the Institute and Dean Berg convinced the family to move it to UM.

He entertained questions from the floor.

The proposal passed unanimously.

Howard Gitlow moved that the Senate not vote on centers and institutes—even school-based—without submission of a budget; the motion was seconded. After considerable discussion, including a number of clarifications, friendly amendments, and modifications, the maker and seconder of the original motion agreed on the following wording: The Faculty Senate establishes an internal operating procedure requiring that school-based centers and institutes must provide a five-year

projection of total expenditures, specifying amounts provided by existing school budgets and by pledged funds, with an indication of which pledged funds have been received and which are yet to be received.

The motion was approved.

UPDATE ON REAL ESTATE AND FACILITIES – INFORMATION ITEM ONLY

Larry Marbert, Vice President, Real Estate, gave a presentation on the University's overall construction plans and some of the obstacles encountered. Michael White, Executive Director, Facilities and Operations, provided an overview of the University's efforts to reduce energy consumption for all operations, and he highlighted some of the programs that have been implemented.

They entertained questions from the floor.

UNDERGRADUATE HONOR COUNCIL AND HONOR CODE PRESENTATION

Dan Stein, President of the Honor Council, and Anita Viciana, Vice President, presented information about the Undergraduate Honor Council's procedures and urged increased faculty participation in the work of the Honor Council. They explained how faculty can solicit help and get information, including requesting the Council to make presentations to their classes and acting as proctors during testing.

They entertained questions from the floor.

EXECUTIVE SESSION [Non-senate members were excused from the meeting at this point.] JAMES W. McLAMORE OUTSTANDING SERVICE AWARD RECOMMENDATION FROM THE GENERAL WELFARE COMMITTEE [See separate Executive Session minutes.]

The meeting adjourned at 5:45 p.m.

Basis: Established under Section B6.6 of the University of Miami Faculty Manual.

Name: Henry Mancini Institute

Mission: The Henry Mancini Institute (HMI) provides advanced pre-professional performers, conductors, and composers with intensive instruction and experiences in the broad diversity of music that is encountered in today's musical environment. The instruction in film music, jazz and popular styles, improvisation, world music, electronic performance, digital music applications, and entrepreneurship provided by major guest artists and resident faculty is far beyond that offered by traditional conservatory training.

Objectives: •

- The Institute will provide its graduate student fellows with rehearsal, performance, and pedagogical experiences led by renowned artists, composers, and conductors.
- The Institute will focus on music across the genres of classical, jazz, pop, film music, world music, and styles yet to be incubated.
- The Institute student fellows will be organized into the Henry Mancini Institute Orchestra and in smaller ensembles appropriate to the music being performed.
- The Institute will provide public concerts that feature renowned artists, composers, and conductors who have worked with the graduate student fellows in preparing the performances.
- The Institute will provide master classes and residencies by a diverse array of highly acclaimed artists.
- The Institute's chamber music groups will have extensive involvement in community engagement activities, reaching out to the community and atrisk students.

Background:

Jack Elliott founded the Henry Mancini Institute in 1996 as an academy for young music professionals. The Institute brought together the most talented post-baccalaureate degree young musician professionals in the summer to compose, arrange, and perform a broad array of music that is appealing to the broad spectrum of today's music listeners. Through this experience, musicians learned the skills beyond those of the classical orchestra. That is, the skills necessary to be successful in today's musical world.

The HMI began having financial problems in the early 2000s and was forced to close on December 31, 2006. Dean Shelly Berg of the Frost School of Music has successfully negotiated with the Mancini family to bring the Henry Mancini Institute to the University of Miami. The academy concept has been reworked to focus on the artist-level graduate students of the Frost School of Music.

Staffing: Artistic Director. The HMI Artistic Director will be appointed for Fall Semester 2009. The Director will lead the Henry Mancini Institute Orchestra in concert and in the final preparations for the concert. Negotiations are currently underway with two renowned artists one of whom is a ten-time Grammy award winner and the other is one of the top ten film composers of all time.

> Institute Faculty. The faculty of the Frost School of Music will lead early preparation for Institute performances.

Henry Mancini Fellows. There will be 45 Mancini Fellows who are graduate students enrolled in the academic programs of the Frost School of Music in the areas of instrumental performance, studio music and jazz, and composition.

Guest Artists. Guest artists will be well known and highly regarded individuals who are active in the musical profession. For the 2008-09 academic year these artists will include Steve Miller, Dave Grusin, Bruce Hornsby, Rickey Skaggs, Maria Schneider, Pablo Ziegler, Joshua Redman, Phil Ramone, Anthony Davis, Jon Secada, Dave Koz, Tom Scott, Eric Marienthal, Eddie Palmieri, Will Lee, Monica Mancini, Gregg Field, and John Corigliano.

Coordinator of Activities. A coordinator of HMI activities will be appointed during the 2009-10 academic year. The Coordinator will oversee basic administrative functions and community engagement activities.

Administrative Support. The Frost School of Music will provide administrative support.

Funding:

The Bulk of HMI funding is in place, utilizing existing faculty lines, master class allocations, and teaching and performance spaces. Twenty-one of the 45 Mancini Fellowships will be awarded from existing assistantships in the Frost School, The Artistic Director and Coordinator salaries will be funded from the Frost Naming Endowment.

The Frost School Strategic Plan calls for development activities to fund the remaining TA stipends and to endow the Artistic Director's chair. The marquee value of this institute, named for one of the most beloved composers in U.S. history, will enhance opportunities for fundraising.

Operating Rules:

The Institute will consist of an Artistic Director, an Advisory Committee consisting of Frost School of Music faculty, 45 graduate student fellows, a Coordinator of Activities, and select faculty from the areas of instrumental performance, studio music and jazz, and composition.

- 1. The Dean of the Frost School of Music will appoint the Artistic Director, the Advisory Committee, and the Activities Coordinator.
- 2. The Advisory Committee will meet on a monthly basis to plan and implement the Institute's activities with close consultation with the Institute's Artistic Director. The Advisory Committee will work with Frost School of Music faculty and the Associate Dean of Graduate Studies in the selection of the Institute's graduate student fellows. The Advisory Committee will review and make recommendations on the best use of funds raised to support the Mancini Institute. The Advisory Committee will seek input from Frost School of Music to ensure the efficient operations of the Institute while attaining the highest artistic levels of performance. This will also include hearing and appropriately responding to any issues that might be identified by the faculty. Robert's Rules of Order will govern all meetings.
- 3. The Artistic Director, the Advisory Committee, and the Activities Coordinator report directly to the Dean of the Frost School of Music.

No result could have modified the conclusion reached by the dean even before letters were solicited and prior to the cognates faculty's considerations of the merits of the case. The dean did not want this professor on his tenured faculty. In the dean's view, diametrically opposed that of the dept and tenured committee, and individuals whose work is not of a particular kind, (and then he describes the kind that he wants) is not tenure-able as opposed to, literally, the kind of work the dean wants. The dept examined the intrinsic merits of the work and used the evaluations of the outside referees to reach the conclusion that the work, in fact, is not intended to be what the dean wants it to be and that it is quite excellent and meets the standards for tenure for it in fact is. It's a completely tenure-able quality particularly in view of the person's extraordinary and outstanding teaching that involves teaching the kind of creative scholarly work that the candidate does."
- -TRB is going to recommend to the President that she set aside as if it never occurred, null and void, the entire tenure proceedings. That gives an opportunity for the dean and candidate another discussion. This goes against the procedure as stated in the Faculty Manual.
