This legislation is now forwarded to you for your action.

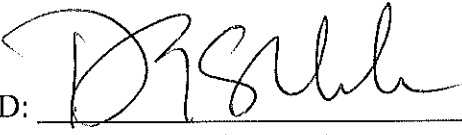

I write to request the Faculty Senate support changing the name of the University of Miami Miller School of Medicine *Department of Medical Library and Biomedical Communications* to the University of Miami Miller School of Medicine *Department of Health Informatics*.

The proposed name change would affect only the name of the academic department. It would not change the name of the Library building, which honors the donor (Louis Calder Memorial Library), nor would it alter the mission or structure of the department.

## Proposal for Departmental Name Change

February 19, 2010

**Background:** *The Department of Medical Library* was founded at the time of the inception of the University of Miami School of Medicine in 1952 and the chief librarian was named Professor of Medical Bibliography. Almost thirty years later the Department of Medical Library was merged with the Department of Biomedical Communications to become the **Department of Library and Biomedical Communications Services**,<sup>1</sup> the name it bears today, and the chief librarian was named Chair. Faculty members in the Department have requested a name change to the *Department of Health Informatics* to reflect their present academic discipline.

The proposed change would affect only the name of the academic department. It would not change the name of the Library building, which honors the donor (Louis Calder Memorial Library) and will continue to provide medical library resources and services.

The first department of medical informatics in the United States is believed to have been founded at the University of Utah in 1964.<sup>2</sup> Other departments followed suit, and twenty years ago Greenes and Shortliffe published a highly cited article in the influential *Journal of the American Medical Association*.<sup>3</sup> The title all but summarizes the article: "Medical Informatics: An Emerging Academic Discipline and Institutional Priority." The authors made a convincing case in encouraging academic institutions to establish academic departments of medical informatics. Today, the American Medical Informatics Association lists over 104 teaching programs in health informatics.<sup>4</sup>

**Definition of terms:** Greenes and Shortliffe defined medical informatics as:

... the field that concerns itself with the cognitive, information processing, and communication tasks of medical practice, education, and research, including the information science and the technology to support these tasks. An intrinsically interdisciplinary field, medical informatics has a highly applied focus, but also addresses a number of fundamental research problems as well as planning and policy issues ...<sup>5</sup>

Stead wrote:

Medical Informatics is a growing discipline, a multidisciplinary field ... By medical, we do not mean M.D., but all parts of the health-care arena: allied health; biological sciences; health-care facilities; health-services research; medical specialties; and nursing.<sup>5</sup>

One year later, Ball, Douglas and Lunin wrote " ... health informatics is being used to describe the field not specific to medicine, but supportive of the full spectrum of health sciences.<sup>6</sup>" More recently, Young (2000) identified that *healthcare informatics* combines information science, computer science, cognitive science and health sciences, with the goal of informing healthcare providers, expanding knowledge and delivering efficient, well-managed healthcare.<sup>7</sup>

Although there has been some confusion about terms in the past, the uncertainty was largely resolved twenty years ago. Common usage has evolved to a preference for the term *health informatics*, which refers to the study of the nature and management of health sciences information.<sup>8</sup>

**Rationale:** Currently the Department of Library and Biomedical Communications is the only University of Miami Miller School of Medicine department that is named for a place (library), rather than an academic discipline.

The Department's academic discipline is *health informatics*, which deals with the resources, devices and methods required to optimize the acquisition, storage, retrieval and use of information and knowledge in health and medicine. The many health informatics accomplishments, resources, teaching programs and research initiatives of Library faculty are not properly recognized by the existing department name. Additionally, the health informatics initiatives of faculty throughout the School of Medicine and UM are not supported by a department of health informatics and so may be less recognized by agencies such as NIH, for which health informatics is vital and an increasing funding opportunity.

It is appropriate to initiate the Department of Health Informatics in what has been the Department of Medical Library. Medical librarians have worked for decades to advance health informatics. The IAIMS (Integrated Academic Information Management Systems) report was jointly issued by Nina Matheson and John A.D. Cooper, respectively heads of the Medical Library Association and the Association of American Medical Colleges in 1982.<sup>9</sup> This report envisioned a future where every health database that could be connected, would be. Today the work that has been accomplished to connect electronic health records with evidence-based databases, electronic images, billing systems and more has come about because of the vision described in the IAIMS report. Most recently (2009) a librarian received the highest award of the American Medical Informatics Association.<sup>10</sup> Her work with metathesauri paved the way for the integration of electronic health records with scholarly research results. When we look to the health sciences libraries at Vanderbilt, Johns Hopkins, the University of New Mexico, State University of New York at Buffalo, the University of Oregon, Indiana, and many others, we see prime examples of librarian leadership in health informatics.

Ball, Douglas and Lunin wrote that the National Library of Medicine was a leader in encouraging and promoting informatics and informatics was identified as one of the Library's domains for long range planning. Almost half of the supplementary funding requested by the NLM in 1990 was to support informatics.<sup>6</sup> Informatics remains an important priority for the National Library of Medicine today, and academic health sciences libraries and their parent institutions nationwide have been influenced by the leadership of the NLM in health informatics. The National Library of Medicine is the primary funder of training, education and research in health informatics.

Although the activities of health informatics might take place in any of several areas at the University of Miami, it is most appropriate that such a department be established in the Medical Library. Our academic department supports equally the education, patient care, research and community programs and activities of all School of Medicine departments. The Library's *Collaboratory* (dedicated space with state of the art information technology and knowledge management support for group problem solving and decision making) is both space and also a symbol of the Library's dedication to fostering interdisciplinary inquiry. Alternatives would place Health Informatics within one department or another. The Library is the best choice to assure equitable representation and collaboration.

Library faculty members believe that having a name that is reflective of our academic discipline will help:

- Cement our role as educators, researchers and contributors to health informatics
- Strengthen our ability to teach relevant, contemporary classes that appeal to students
- Strengthen NIH proposals and our role in them
- Provide an academic home for appropriate faculty who may not fit easily into either clinical or basic sciences
- Facilitate recruitment of needed informaticians to support clinical care and research
- Motivate greater integration of librarians into health sciences education, research, and patient care
- Foster collaboration, with the potential to bring together faculty whose work reporting structure might be elsewhere

#### **Actions:**

- January 9, 2009: Inquiry made regarding process for departmental name changes
- February – May 2009: Medical Library faculty discussed possible names
- September 8, 2009: Medical Library faculty officially requested a change to its academic department name and arrived at two preferred options:
  1. The Department of Health Informatics
  2. The Department of Health Information Sciences
- September 24, 2009: The Library Chair and faculty presented alternative names to the Library Committee. The Library Committee discussed pros and cons and the conclusion was that the Committee supported either new name.
- October 13, 2009: Library faculty again met and identified the preference for the first choice, the Department of Health Informatics. A summary of the discussion follows:  
*Health informatics deals with the resources, devices, and methods required to optimize the acquisition, storage, retrieval, and use of information and knowledge in health and medicine. This choice was selected because it is more reflective of NIH initiatives, is used by forward-looking libraries, and is more future oriented. It allows the School of Medicine to develop a transdisciplinary teaching and research program that can advance our goals and help make us more competitive. Additionally, Health*

*Informatics was found preferable to Health Information Science because information sciences are concerned with gathering, manipulating, storing, retrieving, and classifying recorded information and do not include knowledge capture, which is what the Library Division of Biomedical Communications currently performs. Further, the committee felt the term "health information sciences" might be confused with "medical information technology (MIT).*

- October 13, 2009: The Chair met with the Dean and presented results of the deliberations. The Dean indicated preference for the name, "The Department of Health Informatics."
- October 29, 2009: The proposal was summarized in an email to the Dean, with a request to present the proposal to the Medical School Council.
- December 3, 2009: At the Library update of the Dean's Operational Leadership Group meeting, the Medical Library Chair reported that the library was seeking a name for our academic department that was more reflective of our academic discipline.
- January 12, 2009: Proposal was first presented to the Medical School Council.
- January 26, 2009: Proposal was unanimously approved by the Medical School Council.

**Business costs for change:** There should be no substantial costs associated with this name change, as the name of the Library will remain the same and other changes can be made electronically. No signs are needed. Business cards or stationary would be changed when new supplies are needed. A Web page would be established using currently available resources with no additional charges. A request to change the name on the Miller School of Medicine Web page would be made. No new positions are requested at this time. No funding for joint appointments is anticipated at this time. No renovations are required.

**Letters of support:** Letters of support are presented from the Speaker of the Faculty Council, the faculty of the Department of Library and Biomedical Communications, the Dean of the Miller School of Medicine, the Vice-Provost for Research, the members of the Medical Library Committee of the Faculty Council, the Chair of the Medical Faculty Council, and key individuals who are supportive of this change.



### Addendum March 12, 2010

At the March 10, 2010 meeting of the Faculty Senate General Welfare Committee, a senator asked how medical librarians felt about this proposal, since they would need to take on new roles in teaching and research.

**Response:** This would not be a change, as most medical librarians already teach and conduct research. Because the role of medical librarians in teaching and research may not be obvious to all, some examples follow.

*Teaching:* Most UM Miller School of Medicine medical librarians have taught as part of medical curriculum, in training courses, continuing education and tutorials. Each of the three librarians who teach sections in the Resident Scholarly Activity Program has received The Resident Choice Award for teaching. Librarians have taught in the areas of evidence-based medicine; resources for clinical decision making; management information systems; computer applications in medicine; knowledge management; competitive intelligence; text mining and cluster analysis; measuring scholarly impact; telemedicine; and artificial intelligence among other topics.

*Research and Evaluation:* UM Miller School librarians have conducted research on diffusion of innovation in the adaption of medical information technologies; analysis of outcomes from creating a natural language bot (Native Minds); analysis of a customer service database (Siebel) for new product and program suggestions for the NIH/National Library of Medicine (NLM); applying PubMed's related concepts algorithm to mine other full text databases (The conversation with the GWC regarded whether this type of algorithm could be applied to EPIC electronic health records, which will be administered by the UMMG Executive Office, to find patients with similar constellations of rare symptoms. This is conceivable but not yet attempted.); qualitative analysis of failed medical searches in MedlinePlus; cost benefit studies across multiple telemedicine programs; and many other topics. Extramural funding to support library research efforts has been obtained from the NIH/NLM, DHHS, Southwestern Bell, AT&T and others.

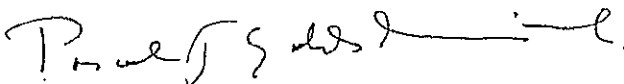

Dear Dr. Altman:

We are writing to indicate our support for the name change of our academic department from the Department of Medical Library and Biomedical Communications. We have been discussing the need for a name change for some time. We feel this is extremely necessary because the current name (1) does not reflect our academic discipline; (2) may lead to misperceptions that undervalue our contributions in medical teaching and research; (3) seems grammatically awkward; and (4) is now inaccurate because the department includes multiple libraries, new information centers and new services that are not reflected by either "library" or "biomedical communications."

The proposed name, Department of Health Informatics, is much more forward thinking and uses terminology familiar to those working in our discipline. The National Library of Medicine has long provided support for teaching programs in health informatics, although none of these awards have come to Florida medical schools, perhaps because Florida medical schools have had no such departments.

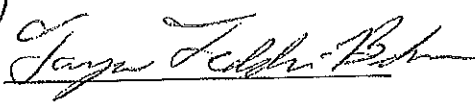
It is fitting and appropriate that librarians seek this change. We have long been leaders in health informatics, dating from the joint release in 1983 of the IAIMS (Integrated Academic Information Management System) Report, jointly issued by the Medical Library Association and the Association of American Medical Colleges. It is significant that the highest award of the American Medical Informatics Association was bestowed this year on a masters-degreed librarian, notably for her work in disseminating health sciences vocabularies and metadata.

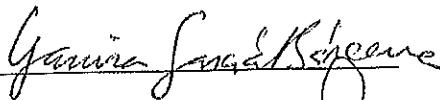

Dear Dr. Moore (Mary):

Like you, several of our researchers have been members of the American Medical Informatics Association for some time. We have watched as others have established health informatics educational and research programs and obtained federal funding for those activities. While many of UM's health informatics efforts have been successful, UM may not have had the same kind of national presence in health informatics that some other academic health sciences universities have enjoyed. I believe that the vision for our Department of Health Informatics will help UM achieve more visibility, but more importantly, it should ultimately help us serve patients even better.
