At its September 19, 2012 meeting, the Faculty Senate unanimously approved the proposal to add the University’s Parking Appeals Committee to the list of Faculty-Administrative Committees in the *Faculty Manual*. For years, the Senate has appointed faculty representatives annually to serve on this committee. The addition of the committee name will bring the *Faculty Manual* into conformity with current practice.
