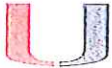

I write to request approval to change the name of the School-based "Knight Center for International Media," to the "Center for Communication, Culture, and Change." The Center is not a University-designated Center or Institute, but rather an "Other Named or Titled Academic Unit." For reference, the "The Knight Center for International Media" was previously named the "Knight Center for Advancement of Modern Media" per Legislation #2006-11.

This change has been discussed and approved by the Knight Foundation and the Provost. The original purpose of the Center was specific to a Knight Foundation grant for the production of media that has expired.

At its fall planning meeting on August 30, 2013, the faculty of the School of Communication voted unanimously to change the name of the Center to the "Center for Communication, Culture, and Change" and I strongly endorse the faculty's vote.
