Proposal for Health Sector Management and Policy Department At the University of Miami School of Business Administration

#### 1. Background

The University of Miami, School of Business Administration, has identified Health Sector Management and Policy (HSMP) as one of three distinctive Areas of Excellence–areas in which the School can draw upon unique assets to develop outstanding programs encompassing state of the art research and exceptional higher education. The School of Business Administration has determined that it is an appropriate time to move Health Sector Management from Program to Department status. This has been approved unanimously by the Health Sector Management and Policy Faculty, the Department of Management Faculty, the Advisory Board to the Program and Centers Health Sector Management and Policy, the School Council, the full Faculty at the School of Business Administration and the Dean of the School.

The School's core health management program, the Executive MBA in Health Sector Management and Policy has been in existence for over 35 years. It is among the Nation's select health care programs to have dual accreditation by The Association to Advance Collegiate Schools of Business (AACSB) and the Commission on Accreditation of Healthcare Management Education (CAHME). It is consistently ranked in the top 10 among all MBA programs for physician executives by Modern Healthcare (Exhibit 1). The program prepares health professionals for leadership positions in health care and health-related organizations. Currently, program alumni lead local, national and global health care organizations, and are an indispensable resource to students. Additionally, the Programs in Health Sector Management and Policy Advisory Board (Exhibit 2) is comprised of over twenty regional, national and global health care industry leaders. The Advisory Board represents the full spectrum of the health care industry, provides curriculum guidance, program financial support, and serves as a resource to students with mentoring and internship opportunities.

The MD/MBA program (Exhibit 3), conducted in partnership with the UM Miller School of Medicine, adds a year of business education following the third year of the traditional four-year MD track. The business curriculum prepares future physicians for the business complexities related to running a private medical practice, heading a group practice or becoming a medical director of a health care organization. Furthermore, it prepares medical students for careers in health sector management, leadership, policy and consulting. As key contributors to the School of Business, MD students provide a unique health care perspective to their course work and have been awarded notable honors from several case competitions and participation in entrepreneurial activities at the School. This background and knowledge base has served our MD/MBA graduates well in obtaining highly regarded medical residencies. Since its inception in 2008, 43 students have graduated from this program.

In the last several years, the Program in Health Sector Management and Policy has introduced a Minor in Health Sector Management and Policy, open to all students in the University. Pre-med students are among the largest grouping of students choosing to take the Minor. Approximately two years ago, the Programs introduced an undergraduate Major in Health Sector Management and Policy. The first graduating class of fifteen will be placed, including our students in GlaxoSmithKline Pharmaceutical's Leadership Program; one student was admitted to Boston University's Master's Program and two students were admitted to Johns Hopkins Master's Program. We currently have 32 students in the Minor and Major.

#### 2. Description

Health care is the largest industry in the U.S. and a source of more than 11 million jobs for undergraduate and graduate students seeking careers in Health Care Management. Because the health care industry has such a huge impact on both U.S. and Global economies, the strategy of the School of Business Administration to identify Health Care Management as an Area of Excellence is appropriate and t the creation of a Department of Health Sector Management and Policy is timely.

A departmental structure will more effectively support the School's effort to attract the best students, provide excellence in research and teaching, and allow the School to compete with other business schools. Faculty resources, management of budgeted resources, coordination of staff and duties, including focused advising would allow further development of academic program offerings and curriculum as well as engagement in innovative thinking and dissemination of high-impact health care focused research which can serve to shape how health care management is conceived.

Currently, the Program for Health Sector Management and Policy is housed in the Department of Management and uses a matrix approach to draw faculty from various functional areas. However, HSMP cannot easily hire and promote health care management faculty given the disparate and divergent views and needs of a department that incorporates several areas of focus. The Department of HSMP would allow for more flexibility to meet the current demands of health care management education in the community, including the development of innovative cross-disciplinary programs, and executive education opportunities.

More importantly, a Department of HSMP would allow the School to attract top researchers who can make significant intellectual contributions, which is essential to growing the reputation of the School and the Programs. Faculty members would be hired and evaluated for promotion and tenure by colleagues who are knowledgeable in the unique field of health care; performance evaluation, objectives and the tenure process would be in line with the faculty development goals and expectations of the School of Business and the University. The Department of HSMP would expect faculty to publish in high-impact research journals appropriate to the field of health care management. Faculty members would also serve to support the research activities of the Center for Health Sector Management & Policy.

Current HSMP goals under consideration are to develop a health care information technology minor; a 5-year combined undergraduate/graduate program; a four course certificate/concentration in Health Sector Management & Policy for full time graduate students and MBA graduates who are looking to expand their knowledge in the health care field; and a Masters in Health Administration (MHA) with an online component. The proposed MHA program will incorporate a Certificate in Business Administration and the curriculum will serve as a model for the creation of additional health care executive education programs as well as cross disciplinary programs.

It is evident that the health care management curriculum is benefitting students university-wide. (Exhibit 4) The introductory course- MGT 270-Introduction to Health Care Administration has consistently been fully subscribed with a great number of students from various Schools and Colleges including students in the pre-med/science track who are interested in medical school. In Fall 2014 t 36 students were enrolled in MGT 270; in Spring 2014 40 students are enrolled with 20 students pursuing a pre-med/science track. It is anticipated that a number of these students will consider the HSMP minor and/or major as they move further along in their studies and experience challenges, or decide to adjust their focus differently from what they originally intended. These students are generally very bright and are high recruited by the university. The HSMP major gives them a viable option as their interests change. It also provides them the understanding of health care administration and policy, so important in their pursuit of a career in medicine.

#### 3. Mission

It is the mission of the Health Sector Management & Policy Department to deliver excellence in health care management and policy education to undergraduate and graduate students; to provide resources to support pertinent research and innovative thinking; and ensure the highest quality academic performance by professors dedicated to the field of Health Sector Management and Policy.

#### 4. Purpose and Goals

Well aware of the need in the health care sector for not only graduate students, but undergraduates, the School of Business introduced an undergraduate minor in Health Sector Management and Policy in fall 2008. The purpose of the minor is to provide students throughout the university community with a basic understanding of the management, economic, organization and financial structure, as well as the legal, ethical and governmental policies affecting the health care industry. Since its formation, interest for the minor has been strong. There were 12 students enrolled in the minor in 2011 and 24 in 2012. This number has been steadily growing. There are currently 33 students enrolled in the minor.

To continue addressing the needs of the sector, the School developed the undergraduate major in Health Sector Management & Policy, which was unanimously approved by the University's Faculty Senate in February 2010. The intent of the major is to prepare School of Business Administration students for careers in health care management and policy, in a variety of health care organizations and public settings, as well as to pursue graduate educational opportunities. The major enables students to gain skills and understanding in the specialized language of health care and to comprehend concepts of management, financing, economics, marketing, process improvement, politics, law and ethics as applied to the health care sector. This was the School's first graduating class of HSMP majors. There are currently 24 students enrolled in the major. It is anticipated that the undergraduate program will seek to become a Full Certified Member of the Association of University Programs in Healthcare Administration (AUPHA) after graduating its second class, a requirement of the certification process. This involves a rigorous peer review process through which AUPHA's standards and criteria are applied.

The Center for Health Sector Management and Policy was created in 2010 to conduct quality research to be published in peer reviewed journals, serve as a resource to the local, regional, national and global media, provide consults on health care management practices, and provide interactive conferences and forums to educate health care and business professionals, policy makers, citizens,

and the University Community. It serves as a vehicle to provide both graduate and undergraduate students research opportunities. The annual health care impact conference sponsored by the Center attracts more than 750 health care professionals, national health care leaders, alumni and students from every subsector of health care to the University; providing an opportunity for the exchange of ideas and discussions on key health care issues. Over 200 students have been able to attend this conference as scholarship recipients through corporate sponsored support, thereby ensuring interest and exposure to the Center. The Center works with faculty members to facilitate special health care programs including as of late a health care compliance boot camp, developed to address the growing need in the industry, as well as workshops for international health care business leaders and policy makers This program has received corporate sponsorship and will be offered to interested students at no cost.

#### Market Analysis

The global health care services market is forecast to reach \$3 trillion by 2015, according to research from Global Industry Analysts. Investment in sectors such as home health care, health care IT and telehealth are expected to continue powering market expansion. The health care sector currently makes up nearly 18 percent of all economic activity in the United States and is expected to grow to over 20 percent in the next eight years. Health care costs continue to rise rapidly in the U.S. and throughout the developed world. Health care is becoming a global industry. Multi-hospital/multi-country systems; global health insurance and pharmaceutical companies; the growth of medical tourism; these are all a reflection of the globalization of health care. This global focus fits well with the growing global approaches of the School of Business Administration.

U.S. Bureau of Labor Statistics reports that the health care industry—which includes public and private hospitals, nursing and residential care facilities, and individual and family services—is expected to grow by 33 percent, or 5.7 million new jobs by 2020. Employment growth will be driven by an aging population and longer life expectancies, as well as new treatments and technologies. Managers in all settings will be needed to improve quality and efficiency while controlling costs, as insurance companies, the government Medicare and Medicaid programs, the Patient Protection and Affordable Care Act and employers demand higher levels of accountability. According to the U.S. Bureau of Labor Statistics, demand for managers will stem from the need to recruit workers and increase employee retention, to comply with changing regulations, to implement new technology, and to help improve the health of their communities by emphasizing preventive care.

On the academic front, we look to our aspirational peers, , including the University of Pennsylvania, Wharton Health Care Management Department who has broken from the traditional public health and health administration models and have sustainable health care focused departments within the business school. It should be noted that the HSMP Program has been invited to apply for membership in an elite group of Business School Alliance for Health Management (BAHM). Memberships is by invitation only. A list of the Membership is included as (Exhibit 5).

#### 6. Library Resources

The University of Miami Libraries currently provides access to numerous databases and journals that are specific to Health Care Sector Management and Policy. Attached is a list of two databases; one is for Health Care Management via Florida Electronic Library and Miami-Dade Library; the second is a list of Health Care Management Research Databases via UM Libraries (Exhibit 6).

#### 7. New Department

The new department will be called the Department of Health Sector Management and Policy. It will have a chairperson, six core faculty and a horizontal system of administrators as outlined below.

#### 7.1 Chairperson and Scope of Faculty

It is anticipated that the Department of Health Sector Management and Policy will be led by interim Chairperson Steven G. Ullmann, PhD, a Professor of Management and Director for Programs in and Center for Health Sector Management and Policy, School of Business Administration. Dr. Ullmann, a highly regarded faculty member with more than 35 years of experience in education, research, and academic management, specializes in health economics, health care management and medical ethics. Ullmann has built strong relationships with various University of Miami entities, allowing him to draw on professional resources within the various University of Miami schools and colleges including the Miller School of Medicine, the School of Nursing and Health Studies, the College of Engineering, the School of Law and the School of Architecture. These important relationships will play key roles in the future development of HSMP programs and research projects. After the Department is formalized and in accordance with the Faculty Manual, the department faculty will serve as the Consultative Committee and advise the Dean on the appointment of the Department Chair.

The faculty departmental structure initially is planned to include six core faculty members. Of the six core faculty, two faculty members are proposed to be newly hired; one at the Associate Professor level and the second at the Assistant Professor level; both will be tenure-track/tenured position's). HSMP department faculty will be expected to publish in top-tier peer reviewed Business/Health Management and Policy journals to be considered for faculty promotion and tenure. See attached list of top-ranked health care journals (Exhibit 7).

The Department of HSMP is expected to grow based on needs as appropriate. It is envisioned that the Department will comprise of a mix of Tenure/Tenure Track/Clinical/Lecturers/Adjuncts of 10-12 faculty members over the next 5-7 years. Succession needs of the Department will be addressed accordingly.

It is anticipated that staffing for the proposed Department of HSMP will be expanded as follows:

- 1. Department Chair will be responsible for tenure & promotion, faculty evaluations and recruiting. The Department Chair will engage in external activities to promote the Department, Program, School of Business Administration and the University.
- 2. Department Faculty
  - a. Associate Professor (Tenured/Tenure Track)
  - b. Assistant Professor (Tenure Track)
- 3. Assistant Director of Undergraduate Programs (Faculty Stipend for Advising/Internships)

Current Program administrative support staff and student support will remain the same.

The proposed Department of HSMP budget and organizational chart are provided in the appendix. (Exhibit 8-Detailed Budget; Exhibit 9-Proposed Organizational Charts Options 1 & 2).

A department allows for the needed infrastructure and flexibility in hiring, mentoring, evaluating, and potentially the promotion and tenure of faculty members in this specialized field.

The Health Sector Management and Policy Department will allow the School of Business Administration to further enhance the delivery of quality health care management and policy education, provide resources to support research excellence, build cross disciplinary programs and expand executive education for the benefit of students, faculty members, the University and the greater business community.

The purpose of this memorandum is to summarize the School's faculty recruiting plans for the proposed Department of Health Sector Management and Policy (HSMP), which is part of the School's overall five-year hiring plan to be included in the FY15 budget.

The School created a tenure-track position (Position # 47056) in healthcare (currently falling under the Management Department). Recruiting for this position was put on hold pending approval of the new department and will likely be filled in FY2016. The school also plans to convert a part-time lecturer to a clinical faculty member in FY2016. Also included in the School's five-year plan is the hiring of an additional tenure-track faculty member, who will join the School at the start of FY2017. These two positions are included as line items in the proposed Department of Health Sector Management and Policy FY15-FY19 budget, part of the five-year plan as submitted to the Provost.

#### Dear Professor Ullmann:

I would like to offer my support and encouragement to you and your associated faculty in your efforts to establish a department of Health Sector Management and Policy within the School of Business Administration at the University of Miami.

Kaiser Health News recently reported that healthcare costs in the United States currently represent 17.9 percent of the Gross Domestic Product (GDP) and are expected to increase to over 20 percent of GDP by 2021. Contributing to this increase in expenditures are the demographic trends in the country that portend over 20 million people becoming eligible for Medicare over this same period. With these dramatic increases in both the number of people and the amount of money spent on total healthcare in the county, the need for efficient management and sound policy in the health sector has never been greater. The establishment of a Department of Health Sector Management and Policy at this time is not only a very propitious initiative, but also one that will coalesce the efforts of many faculty across the Business School and around the University.

As the current Chair of the Department of Management Science, I have seen a marked growth of interest and research in the health sector among our faculty and in our professional organizations. Within the department, Professor Howard Gitlow and his former student, Richard Melnyck, are currently leading the UImprove program at the University of Miami Health System. The UImprove teams of students and faculty have already produced millions of dollars of savings through their work. Additionally, Professor Yongtao Guan leads a group of faculty in the department in health sector - and bio – statistics. The group works closely with the Department of Biostatistics at the Miller School of Medicine on both research and teaching.

Within the professional society of Management Science, INFORMS, the society now holds a national meeting on healthcare operations research, systems engineering, and analytics.

At the 2011 INFORMS Healthcare Conference in Montreal, I had the privilege to arrange and chair a research session of papers contributed by faculty from both the University of Miami's School of Business and the College of Engineering.

I also currently serve as the Chair of the Department of Computer Information Systems in the School of Business. The Computer Information Systems department has been part of the Executive MBA program in Health Sector Management and Policy since its inception. As new requirements for the management of health sector services and technologies have increased, so has the particular need to understand health sector information technologies. The Department has responded to this need in various ways. Dr. Sara Rushinek, for example, has developed a new course in healthcare informatics and has attracted students from business, nursing, and medicine to her classes. The Department has also hired additional faculty with both experience and expertise in these areas to meet expanded teaching needs and has begun the discussion of a health sector minor as part of the curriculum in information technology.

I believe the support for the establishment of a Department of Health Sector Management and Policy should find a broad base within the faculty of the School of Business and across the University. Additionally, the establishment of the Department at this propitious time will provide a needed level of focus and support for many of the faculty's health sector initiatives in both teaching and research.

You have my enthusiastic support for your proposal.

#### Minor in Health Sector Management and Policy

The purpose of the minor in Health Sector Management and Policy is to provide the student with a basic understanding of the organizational, management, economic and financial structure, as well as the legal, ethical and governmental policy of the health care industry.

Appropriate candidates for this minor would include: students interested in exploring the health care sector, working in the legal, management or policy making aspects of the health care sector or those wanting to have an augmentation to their health sciences, nursing, pre-med, pre-law or pre-MBA/MPA studies.

The 12 credit hour minor is made up of four courses, three required and one option as indicated below:

#### MGT 270 Introduction to Health Sector Administration –

This course provides a basic understanding of the components of the health care sector and their interrelationships. The role of hospitals, ambulatory care (including physicians), long-term care, mental health care, hospice care and pharmaceuticals will be examined. The role of government financed (Medicare and Medicaid) and private health insurance in affecting decision making by health care consumers and providers will be examined as well. A historical context will be used.

No prerequisite required

#### ECO 386 Health Economics –

This course applies the tools of microeconomic analysis to the health care sector. By examining the actors and issues in this market, students are able to discuss policy issues from an economic perspective.

Prerequisite: ECO 211 and 302

#### BSL 460 Health Care Law and Ethics –

This course is designed to offer the business student an appreciation of the legal forces and ethical consideration in Health Care Administration within the United States. Prerequisite: BSL 212


differences in ranking for nine journals were significant. This shifting in the relative ranking between quality and relevance is consistent with Barman, Tersine, and Buckley's (1991) findings of variation in the rank orders of quality and relevance for production/operations management journals. Also, the research found no significant differences among journal quality rankings based on tenure, academic rank, or administrative responsibility.
