# Proposal for the Establishment of the HIV/AIDS Institute at the University of Miami Leonard M. Miller School of Medicine

#### 1. BACKGROUND

This proposal seeks to formally establish an interdisciplinary HIV/HIV/AIDS Institute at the University of Miami Leonard M. Miller School of Medicine. The Institute will be called the HIV/AIDS Institute.

Acquired immunodeficiency syndrome (AIDS) is a disease of the human immune system caused by infection with the human immunodeficiency virus (HIV). AIDS was first recognized by the Centers for Disease Control and Prevention (CDC) in 1981 and its cause—HIV infection—was subsequently identified in the early part of the same decade. From its discovery to 2012, AIDS has caused an estimated 36 million deaths and approximately 35.3 million people are living with HIV globally. HIV/AIDS is considered a pandemic and represents a significant challenge in global health.

The Miller School's commitment to HIV/AIDS research and treatment can be traced back to the early 1980s when UM doctors began to see patients with immune system disorders. Although the Miami patients included homosexual men, it was significant that the patients also included heterosexual men and women from Haiti. In March 1983, the UM physicians published the first description of AIDS in heterosexual patients in the *Annals of Internal Medicine*.

Beginning in 1988, the Miller School created the UM Comprehensive AIDS Program (CAP). This primarily clinical program coordinates data collection, HIV surveillance, community outreach, and funding for HIV care from sources such as Ryan White Title I and the State of Florida. In 2007, UM's extensive research efforts in HIV/AIDS were recognized with a five-year, \$3.6 million grant by the National Institute of Allergy and Infectious Diseases of the National Institutes of Health to establish a Developmental Center for AIDS Research (DCFAR). With that award, UM became home to the first NIH-funded AIDS research center in Florida. The DCFAR achieved designation as a full Center for AIDS Research (CFAR) in 2013 and joined the 18 other academic centers nationally as a leader in HIV/AIDS research.

There is an urgent need for an integrated, interdisciplinary institute that offers the expertise, infrastructure, and resources necessary to organize and energize HIV/AIDS science and advance translational and clinical research and education in HIV/AIDS at the Leonard M. Miller School of Medicine. The HIV/AIDS initiatives at the Miller School are robust but fragmented. The creation of an HIV/AIDS Institute will position the HIV/AIDS programs at the Miller School for the next chapter in their impressive history.

#### 2. MISSION

The HIV/AIDS Institute coordinates and integrates all AIDS research and clinical activities at the Miller School of Medicine. The mission is to stimulate innovation, support interdisciplinary collaboration and create synergy among the School's diverse HIV/AIDS initiatives and programs with

the goal of speeding significant advances in understanding, preventing and treating HIV infection and AIDS associated malignancies.

Although the HIV/AIDS Institute will initially be based at the School of Medicine, it is anticipated that, over time, the HIV/AIDS Institute will become a locus for the establishment and development of fruitful collaborations across other University Schools and Colleges by bringing together and matching interests and expertise in an intentional and productive manner. At such time as those collaborations are established, the HIV/AIDS Institute would be taken through the proper University procedure for consideration as a University Institute.

#### 3. ORGANIZATION AND MEMBERSHIP

#### **Organization**

The proposed HIV/AIDS Institute will be led by a Director, who is appointed and reviewed annually by the Dean of the Miller School of Medicine. The HIV/AIDS Institute will initially consist of 4 components – a Research Arm, a Clinical Care and Outreach Arm, a unit focused on statewide initiatives, and a Philanthropic Arm. Each unit is headed by an Associate Director, who is appointed by the Director, in consultation with the Dean of the Miller School. Each Associate Director is reviewed annually by the Director. This organization is explained in more detail below.

## HIV/AIDS Institute Director:

The Director is responsible for articulating and representing the vision of the HIV/AIDS Institute as well as the overall leadership and management of the Institute, including the component parts. Dr. Mario Stevenson, Ph.D., Chief, Division of Infectious Disease is the proposed Director of the HIV/AIDS Institute. An internationally recognized leader in the field of HIV/AIDS, Dr. Stevenson previously directed the Center for AIDS Research at the University of Massachusetts Medical School and is currently co-Director of the UM CFAR.

#### Research:

## Center for AIDS Research

The Center for AIDS Research (CFAR) is an NIH-funded initiative designed to enhance and coordinate UM's AIDS research activities in basic, clinical, and behavioral/social sciences. As such, the CFAR will form the Research Arm of the HIV/AIDS Institute and will foster and promote growth in AIDS and HIV related research programs, including education and mentorship, at UM and at partnering institutions. Inclusion in the HIV/AIDS Institute will not alter the existing administrative structure of the CFAR. Dr. Savita Pahwa will continue to serve as CFAR Director with Drs. Stevenson and Margaret Fischl of the Division of Infectious Diseases as Co-Directors. The current CFAR administrative component (and associated facilities and administrative (F&A) costs currently returned to the CFAR) will be leveraged for the HIV/AIDS Institute.

## Prevention Sciences

The focus on prevention science will be a key part of the Research Arm of the HIV/AIDS Institute at the University of Miami Miller School of Medicine, and will expand on current and ongoing activities. These activities emphasize epidemiologic, intervention and biomedical studies addressing primary and secondary prevention needs of people at risk and living with HIV. Specifically:

- **Primary HIV Prevention** in at risk population with special emphasis to vulnerable populations. This includes ethnic and sexual minorities and substance abuse populations. The main areas of interest are pre-exposure prophylaxis, testing and behavioral interventions addressing the needs of these populations.
- **Secondary HIV prevention** in vulnerable HIV infected populations. These include ethnic minorities, substance abusers, low socioeconomic status and hospitalized HIV patients. The main areas of interest are linkage, retention and re-engagement to care.

The prevention science and activities are enhanced by

- Promoting active involvement of south Florida community-based organizations to collaborate with the University of Miami.
- Providing UM and Miami-Dade County community investigators with consultation and resources to enhance recruitment and retention in community and clinic-based settings of vulnerable HIV at risk or infected populations, with special emphasis on the most vulnerable and hard to reach populations.
- Expanding the opportunities for prevention scientists to collaborate with clinical and laboratory scientists.

## PhD Program in Prevention Science and Community Health

The purpose of the proposed interdisciplinary PhD program in prevention science and community health is to train the next generation of researchers who are committed to reducing the mortality and morbidity attributable to behaviorally based, preventable causes of illness, disability, and death such as HIV/AIDS – and to promoting community health – in the United States and abroad. We propose to train doctoral students whose expressed objectives are to join the prevention research workforce. There is already a great deal of prevention-related expertise in the Department of Public Health Sciences, where the proposed Ph.D. program would be housed, as well as in other schools and departments around the University of Miami. Doctoral students will have ready access to faculty who can train students in cutting-edge prevention models and methods as well as community health. The time is right for such an endeavor.

The importance of prevention is underscored by the leading causes of death between 1990 and 2000 (Mokdad, Marks, Stroup, & Gerberding, 2004). Of the top nine causes of death during that time, seven were behaviorally based and preventable: tobacco use, poor diet and physical inactivity, alcohol consumption, motor vehicle crashes, firearm use, unsafe/unprotected sexual behavior, and illicit drug use. The National Prevention Strategy, an important component of the Affordable Health Care Act, was adopted by the Obama Administration in 2011 as a way of addressing the problem of preventable causes of illness and death. The priorities within the National Prevention Strategy include creating healthy and safe communities, eliminating health disparities, providing clinical and community prevention services, and empowering people. Similarly, the University of Miami Miller School of Medicine's mission includes personalized preventive care and health promotion, integration of prevention and wellness principles into medical practice, emphasizing a scholarly approach to wellness and health, and promoting health equity across various segments of the population. These principles dovetail nicely with the field of prevention science and community

health, and with the expertise among the faculty within the UM Department of Public Health Sciences, and specifically within the Division of Prevention Science and Community Health. The proposed PhD program's curriculum can serve as a resource for training faculty, post-doctoral fellows, and other HIV/AIDS Institute affiliates interested in developing, adapting, and translating effective HIV preventive intervention into community practice.

## Clinical Care and Outreach:

Comprehensive AIDS Program

At UM, the clinical care of individuals living with HIV is coordinated through the Comprehensive AIDS Program (CAP). The Clinical Care and Outreach Arm of the HIV/AIDS Institute will expand on the CAP infrastructure to combine the current UM activities in HIV/AIDS clinical care operations with those of partnering institutions and community based clinics. By doing so, the creation of the HIV/AIDS Institute will greatly advance UM's clinical impact in HIV/AIDS while enlarging a patient base from which to recruit subjects for research studies. Inclusion in the HIV/AIDS Institute will not alter the existing administrative structure of the CAP. Dr. Michael Kolber, the Director of the Comprehensive AIDS Program, will serve as the Associate Director of the Clinical Care and Outreach Arm of the HIV/AIDS Institute.

## Statewide Initiatives:

Under Dr. Stevenson's leadership, the 2014 State of Florida legislature has designated \$1,000,000 in nonrecurring funds from the General Revenue Fund for academic and research institutions designated as Centers for AIDS Research (CFAR) by the National Institutes of Health with a goal to enhance high quality HIV/AIDS research projects conducted in response to the health needs of Florida's citizens (Specific Appropriation 491). This is the first step in establishing a state-funded HIV/AIDS grant program that would support all aspects of basic and clinical HIV/AIDS research at UM and other Florida research institutions. Similar to the Florida Biomedical Research Program, the objective is to create a state funding mechanism to support innovative and high impact AIDS research projects so that they can go on to compete for Federal and other grant funds. Florida has been heavily impacted by the HIV/AIDS epidemic. The state continues to rank third in the nation in the cumulative number of AIDS cases (126,581 in 2012) and second in the nation in the cumulative number of HIV cases (49,058 in 2012). The Florida legislature has a history of earmarking state funds to support biomedical research in specific areas that affect Floridians and for which federal grant opportunities exist (Florida Biomedical Research Program). The objectives of the state funding initiative within the HIV/AIDS Institute are to (1) lead the effort to create the State program, and (2) once formulated, to provide administrative and scientific oversight for the initiative. In his role as Director, Dr. Stevenson will continue to lead the effort to establish recurring funds for the program. As the statewide efforts grow, it is anticipated that the CFAR administrative structure will be expanded to meet the needs of the state program, including the designation of an Associate Director.

## Philanthropy:

The lack of a nidus for HIV/AIDS creates a significant hurdle for developing philanthropy. The HIV/AIDS Institute will include a philanthropic arm that, in close coordination with Medical Development, will enhance the visibility of HIV/AIDS research and clinical efforts at UM and identify philanthropic sources that support the missions of the HIV/AIDS Institute. Dr. Stevenson has

worked closely with the Palm Beach Infectious Diseases Institute (PBIDI), a regional non-profit that raises funds for infectious diseases research, and such a partnership with PBIDI is critical for the success of the HIV/AIDS Institute's fundraising efforts. Dr. Istvan Krisko, Director of the PBIDI, will serve as the Associate Director, UM/PBIDI and will work with Medical Development to identify prospective donors, secure gifts, and ensure that funds are allocated in a way that has the maximum impact on HIV/AIDS research and clinical care while meeting the donor's vision for the gift. Under such a structure, philanthropic efforts may be made using entity names such as "HIV/AIDS Institute," "HIV/AIDS Institute," and "Infectious Diseases Institute." An agreement is underway between Medical Development and the PBIDI for this purpose.

## Administrative Support:

The HIV/AIDS Institute will leverage existing administrative staff within the CFAR and, as pilot funding initiatives grow, will employ additional administrative support personnel to administer those pilots. If the CFAR is not renewed beyond 2019, administrative support will be subsidized by philanthropic dollars

## HIV/AIDS Institute Internal Advisory Board:

The HIV/AIDS Institute Internal Advisory Board (Board) meets quarterly to provide feedback and consultation to the Institute Director regarding the Institute's activities, including scientific progress, clinical care, community connections, needs, and new initiatives. The Board will be comprised of the HIV/AIDS Institute Director and the Associate Directors of each component. Other Miller School of Medicine or University leaders will be invited at the discretion of the HIV/AIDS Institute Director on an as needed basis.

## HIV/AIDS Institute Governance Committee:

The HIV/AIDS Institute Governance Committee (Committee) meets annually to provide feedback and consultation to the HIV/AIDS Institute Director regarding the Institute's progress and future plans, including development and strategic planning. The Committee will be comprised of the HIV/AIDS Institute Director, the Dean of the Miller School of Medicine, a representative from the Palm Beach ID Institute appointed by the Director, a representative from the CFAR External Advisory Board, and two external luminaries — one world class expert in fundamental aspects of HIV/AIDS biology and one international leader in HIV/AIDS clinical care or patient/community advocacy. Other Miller School of Medicine or University leaders will be invited at the discretion of the HIV/AIDS Institute Director on an as needed basis.

## **Membership**

The HIV/AIDS Institute will not have a formal membership process. The Institute openly seeks and supports research and activities related to its mission and does not have formal members. Per University of Miami policy all faculty and voluntary physicians are required to have an appointment through a Leonard M. Miller School of Medicine Department. University faculty interested in affiliating with the Institute can contact Dr. Stevenson. Membership in the HIV/AIDS Institute or participation in HIV/AIDS Institute activities will not impact how indirect costs (IDCs) held by that member are distributed. IDCs of HIV/AIDS Institute members will remain with that member's primary departmental affiliation unless otherwise negotiated and agreed upon.

5. Space


The creation of the HIV/AIDS Institute does not require any new space allocation.

6. Funding Sources and Budget Projections

The HIV/AIDS Institute is being initially supported by IDCs from the CFAR grant and a gift from the PBIDI. No additional dollars are required from UM. The HIV/AIDS Institute predicts that a more directed and consistent approach to philanthropy will grow the funds already available via the PBIDI. The current agreement includes a \$900,000 allocation from PBIDI. All members are expected to seek external funding for their research, thus there are high expectations for significant growth in sponsored funding. The State funds will be used to support collaborative research at UM and at partnering Florida institutions with CFAR designation. The table below illustrates the near-term financial projections for HIV/AIDS Institute.

UM doctors began to see patients with immune system disorders at the earliest stages of the AIDS epidemic and in 1983 UM physicians published the first description of AIDS in heterosexual patients in the Annals of Internal Medicine. Both the research and clinical care for HIV/AIDS patients grew in parallel over the following three decades. The Miller School created the UM Comprehensive AIDS Program (CAP), a primarily clinical program that coordinates data collection, HIV surveillance, community outreach, and funding for HIV care from sources such as Ryan White Title I and the State of Florida. The Miller School's research efforts in HIV/AIDS are significant and culminated with the designation as a Center for AIDS Research (CFAR), a multi-million dollar grant from the National Institute of Allergy and Infectious Diseases. In order to move these important Our efforts in HIV/AIDS are strong but siloed. initiatives to the next level we need an integrated infrastructure that combines research and clinical care with advocacy and philanthropy. The formalization of the HIV/AIDS Institute will accomplish that goal. The School is fully committed to the success of the HIV/AIDS Institute and will continue to direct the facilities and administrative costs recovered via the CFAR to support these initiatives. I fully endorse the creation of the HIV/AIDS Institute without hesitation or reservation and look forward to the Senate's approval of this vital institute.
