Subject: Faculty Senate Legislation #2015-18(B) –Bachelor of Music in Professional Studies

(BMPS) Major, Frost School of Music

The Faculty Senate, at its February 24, 2016 meeting, had no objections to the addition of a Bachelor of Music in Professional Studies major, in the Frost School of Music. The proposed major will allow students to work closely with an advisor to develop individual goals and design a personalized program of study. The major will allow students to tailor their curriculums to match their diverse personal and professional goals in congruence with the rapidly changing music industry. The addition of this major will require participating students to: (1) demonstrate and develop advanced competence in Music Performance on their instruments; (2) develop proficiency in ensemble performance skills necessary for participation and functionality as a professional; and (3) develop the technological proficiency necessary for an entry-level career in the music profession.

Letter of Explanation

The Frost School of Music offers 12 majors and 4 music minors. Each major is organized in three categories:

- General Education Courses including English, Math, and Cognates (27 credits + 3 musicology)
- Experiential Music Curriculum Core Courses (48 credits)
- Courses in the Major (45-52 credits)

The General Education and Experiential Music Curriculum Core Courses are essentially the same for all 12 degree programs. The degree programs vary in the upper level courses that are required in the Courses in the Major.

The proposed degree, Bachelor of Music in Professional Studies maintains the same requirement for the General Education Courses and the Experiential Music Curriculum Core Courses. However, it provides more flexibility and elective choice for the remaining 45 credits.

This will allow students to work closely with an advisor to develop individual goals and design a personalized program of study. While most music degree programs are highly prescriptive, the proposed degree program will allow students to tailor the curriculum to match their diverse personal and professional goals, as well as adjust to the rapidly changing music industry.

Students will select approved electives with the assistance of a guidance committee consisting of: Faculty Advisor, Senior Academic Advisor, and the Associate Dean for Undergraduate Studies.

Student Learning Outcomes and Assessments

Student Learning Outcome 1: Students will demonstrate and develop advanced competence in Music Performance on their instrument.

Assessment Measure 1: During weekly private lessons, the studio teacher will assess student's instrument specific musicianship skills (Selected from the Frost Master Rubric). Each performance component is scored on a 1-4 scale (interpretations of the performance scores are provide via the Frost Master Rubric).

Assessment Measure 2: At the end of each semester of private lessons on the major instrument, students perform works and exercises that reflect the content of private lessons before a jury comprised of the applied contemporary music faculty. Student performances are scored using the Frost Music Assessment Report. Selected performance components are scored using a 1-4 scale (interpreted using the Frost Master Rubric).

Student Learning Outcome 2: Students will develop proficiency in ensemble performance skills necessary for participation and functionality as a professional.

Assessment Measure 1: Student interactions with the experiential music curriculum at the Frost School perform in ensembles regularly. Student achievement in these ensemble settings is measured using the Frost Experiential Performance Rubric

Assessment Measure 2. Student ensemble functionality will be informally assessed through participation in live performance within the University of Miami campus.

Student Learning Outcome 3: Students will develop the technological proficiency necessary for an entry-level career in the music profession.

Assessment Measure 1: Students will produce clear and comprehensible sheet music (e.g. scores, lead sheets, etc.) using music notation software. Instructor evaluations of their sheet music will be used to measure the mastery of this technology. Required for all students in all courses (See Appendix).

Assessment Measure 2: Results from the Graduating Student Survey indirectly measures student ability to use technology (See Appendix).

On January 29, 2016, the Frost School of Music submitted a proposal notifying our office of its intent to implement a Bachelor of Music in Professional Studies (BMPS) program. The program is intended to launch in the fall of 2016.

The 120-credit BMPS program will be comprised of existing courses and the same core curriculum as the other undergraduate degree programs presently offered at the Frost School of Music. Requirements will include 48 credits of Experiential Music Curriculum Core Courses, 45 credits in the Professional Studies major, and 27 additional credits in General Education. Proposed Student Learning Outcomes (SLOs) for the BMPS degree program appear satisfactory; although it should be noted that standards will be expected for all measures associated with each SLO as part of the program assessment process.

The BMPS program will be submitted to the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) as a notification. A response is generally received 3-4 months after the notification submission.
