Subject: Faculty Senate Legislation #2015-19(B) – Deactivate the Master of Music in Collaborative Piano, Frost School of Music [Reference Legislation #2015-20(B)]

The Faculty Senate, at its February 24, 2016 meeting, had no objections to the proposal submitted by the Frost School of Music to deactivate the Master of Music in collaborative piano currently housed within the Department of Keyboard Performance effective spring 2016. The supporting materials outline the reasons for the request to deactivate this programs that include: the curricula duplicates many of the courses already required in other graduate program in the department ; all students in the department are already performing in collaborative ensembles; the department is considering revising its other two degree programs, so that there is no need for a separate degree program to focus solely on collaborative piano; and the department faculty member who previously directed the Graduate Degree Program has retired.

Dear Dean de l'Etoile:

The Piano Department would like to deactivate the Collaborative Piano program. Our reasons for this decision are:

1. The Collaborative curriculum duplicates many of the courses already present in the Performance degrees. MKP is working on an all-inclusive DMA degree curriculum that will include collaborative, pedagogical and solo elements.
2. All members of the current performance faculty in MKP have international and national reputations as solo and collaborative artists. The performance faculty already does large amounts of collaborative coaching and the department has no need for a collaborative faculty line.
3. Piano Performance students perform regularly in collaborative groups and do accompanying for all performance departments at the Frost School. The Staff Accompanist for the school, who has an enormous background of collaborative experience to draw from, coaches all students with accompanying assignments.
4. The pianistic level of the collaborative applicants and students has historically been, unfortunately, well below the desired level of technical and musical accomplishment shown by students in the Keyboard Performance, and Keyboard Pedagogy/ Performance degrees. This is highly undesirable and creates many problems at lessons, piano classes and Forums as collaborative students take lessons with the performance faculty.

1. The curricula for these degree programs duplicate many of the courses already required in other graduate degree programs in the MKP Department, such as Piano Performance, and Keyboard Performance and Pedagogy.
2. All students in the MKP Department are already performing regularly in collaborative ensembles, thus they are still gaining this valuable experience.
3. The MKP Department is considering revisions to its other two degree programs, to include collaborative, pedagogical, and solo elements. Consequently, collaborative performance will still be encouraged and cultivated. However, for the reasons listed above, the MKP faculty do not see a need for a separate degree program to focus exclusively on Collaborative Piano.
4. The MKP faculty member who previously directed the Graduate Degree Programs in Collaborative Piano has retired.

Currently, three students are enrolled in the DMA degree program in Collaborative Piano. Two of these students have completed all required coursework and simply need to complete their Doctoral Essay research. Such work can be done under the supervision of existing MKP faculty. One student is completing the final semester of coursework, including the Doctoral Essay research, and intends to fulfill her degree requirements this spring 2016 semester.
