February 2017 Undergraduate Grading Report Fall 2016

Annual Report on Undergraduate Grading Prepared by the Faculty Senate Committee on Academic Standards¹

Purpose of this Report: This report provides a Faculty Senate sponsored assessment of grades earned by full-time students by teaching school.

Summary: The average grade point average (GPA) earned by undergraduates and new freshmen continues to remain steady at 3.34. The range of undergraduate GPA is 0.42, with the Miller School of Medicine and the Frost School of Music having the highest GPA (3.62 for both) and the College of Engineering the lowest (3.20).

Sixty percent of all grades for full-time degree-seeking undergraduates were As while only 4% of all grades were either Ds or Fs (Table 1).

For new freshmen, the Miller School of Medicine has the highest GPA (3.74), followed by the Frost School of Music and Nursing and Health Sciences (3.71 for both). Freshmen students in the School of Business Administration had the lowest GPA (3.23). New transfer students in the Frost School of music had the highest GPA at 3.61. New transfer students in the College of Engineering and the School of Nursing and Health Studies had the lowest GPAs, averaging below a 3.0, at 2.85 and 2.97, respectively. The retention rate for new freshmen decreased 1.3% while the retention rate for new transfers increased by 1.3%.

GPA Statistics for Freshmen and All Undergraduates: An assessment of the GPA statistics shows little variability over the previous years. As shown in Tables 2 and 3, the overall Fall 2016 undergraduate average GPA was 3.34 (up 0.03 from last year), and the GPA for new freshman was 3.35. Table 4 shows the GPA results for new freshmen over the past four years with little variability in mean GPA over time. The GPA of new transfer students continues to lag below the GPA for new (Fall) freshman but has remained steady since last year and is up from previous years.

Fall 2015-Fall 2016 Retention Statistics for New Freshmen and Transfers: As seen in Table 4, the retention rate of new freshmen decreased from 92.1% to 90/8% (-1.3%) while the new transfer retention rate increased from 89.4% to 90.7% (+1.3%) from last year. This 90.7% retention rate for new transfer students is a seven-year high.

CONCLUSION AND RECOMMENDATIONS

Grading patterns have not changed much over the years. New freshmen and transfer retention rates hold greater than +90%, but the new transfer GPA continues to lag behind that of the new freshmen. The current Academic Standards Committee recommends the 2017-2018 Academic Standards Committee continue to monitor grade distributions, GPA, and retention patterns and to address any areas in need.

The 2017-2018 Committee may also consider examining the grade distribution of pure didactic classes and labs by course and section size (including independent study and practicum type courses) to achieve a finer-grained picture of grade distribution. In addition, to address the lagging GPA of new transfer students, the 2017-2018 Committee may request a report on admission standards for transfer students and the orientation services and academic resources available to transfer students.
