business majors, Business School

The Faculty Senate, at its January 31, 2018 meeting, voted unanimously to approve the proposal of the Business School to revise the Business Law minor for non-business majors. The existing Business Law minor will not change for Business majors. The revised minor was created to offer students a way to prepare undergraduates for a career in law. By revising the required coursework, non-business majors receive a broader introduction to the law minor.

The revised minor requires the same number of credit hours as the current minor, and requires no new courses or resources.

This legislation is sent to you for your action.

Purpose and Goals of the LST Major and BSL Minor

Business students majoring in Legal Studies or minoring in Business Law acquire a basic

understanding of the legal system and how the law and regulations can serve both as a constraint and

a source of value in the successful operation of a business. They learn ways to analytically approach

business problems and are trained to make better business decisions informed by knowledge gained

in the major about the law, compliance, and business ethics. As such, the major and extant minor

(which differ only in the total number of electives that must be completed) provide a strong foundation

for careers in or supplement to majors in finance, management, human resources, risk, compliance,

and for employment in any capacity in any industry that is subject to significant government regulation.

As something of an unintended consequence, the coursework has proven equally valuable to business

students as a foundation for exploration of and preparation for a career in law. So, for example, in

each of the last six years, at least one and typically two or more Legal Studies graduates has

matriculated to Harvard Law School after completing their bachelors in business with the Legal Studies

major. Similarly, other business undergraduates with the LST major have gone on to other prestigious

law schools at the University of Virginia, University of Chicago, University of Pennsylvania, NYU, and

the University of Miami, among others.

Unsurprisingly, then, nonbusiness students studying Communication, Education, Music, and the

many disciplines in Arts & Sciences, who are interested in pursuing law careers/law school admission,

have also found the business law coursework valuable. The business Legal Studies major is not

available to them, but UM students outside business have increasingly sought the Business Law minor

to complement their non-business majors and degrees. As of November 16, 2017, 118 of 197 students

declaring the Business Law minor were from outside the Business School.

Reason for Establishment of a Revised BSL Minor for Non-Business Students

The Business Law minor was designed to serve business students intending to append it to a business

major. As such, it requires two distinctly business-focused courses: one from the business core of

required courses (BSL 212, Introduction to Business Law), and the other a capstone directed at future

business managers (BSL 485, Managing the Legal Factor). With the growth in the number of non-

business students employing the minor to explore the law, the curriculum committee of the Department

determined to create an alternate minor that is more appropriate to this audience.

Demand for Graduates/Market Analysis

As the new minor proposed below is simply a variant on an existing minor and not a new major, there

is no available market data regarding demand for graduates with either the existing or the proposed

BSL minor. Instead it is assumed that the student's major will drive employment choices and career

trajectory. However, benchmarking was conducted to ascertain what other similarly-situated and

aspirational business schools offer in the way of legal studies and business law.

While accredited business schools must incorporate business law into their required curricula at both

the undergraduate and graduate levels, most business schools offer neither a major nor a minor in

law (see, e.g. Michigan, Boston College, GW). Those that do offer a business law or legal studies

major and/or minor to business students do not offer these to non-business students (e.g. Wharton,

Indiana Kelley, Tulane). Therefore, from what we can discover, Miami is unique in this regard.

Proposal for Revised Minor Curriculum for Non-Business Students

All members of the Business Law Department, and therefore, all members of the department's

curriculum committee, are lawyers familiar with law school curriculum and admissions process.

Additionally all committee members have for years written successful recommendations for students applying to law school. Their considered and expert opinion is that a business law program designed for non-business students should be different from that sought by and required for business students seeking careers at the intersection of business and law (or law and business). In short, that curriculum would *not* include the distinctly business-oriented coursework, i.e. BSL 212 and BSL 485.

Instead, the curriculum committee determined, undergraduate students from outside business looking to study law at the undergraduate level—whether to prepare for law school or simply to become more law savvy citizens—would benefit from a broader introduction to the law such as is provided in BUS 202 Introduction to the Legal Environment (survey course that well serves such students as a required foundation), as well as an additional choice from among the many electives offered in the department, e.g. Law of Financial Transactions, Corporate Law, Intellectual Property Law, International Law, Real Estate Law, etc.

Thus, the revised minor for nonbusiness students should be structured as follows:

No new courses and no new resources are required to launch this new minor. Revisions to the Academic Bulletin can be accomplished easily.

This memorandum is intended to memorialize my support for the establishment of a revised curriculum for non-business undergraduate students pursuing the Business Law minor. The attached proposal has been approved unanimously at all stages within the School.

The revised curriculum was developed by the Business Law Department's Curriculum Committee and recommended to the faculty on Friday, September 22, 2017; thereafter it was approved unanimously by the department's Regular Faculty on October 6, 2017 at a duly convened department meeting. The School-wide Undergraduate Business Education Committee considered the proposal on October 11, 2017 and sent it forward with unanimous support to the School Council. The SBA Council considered the proposal at its November and December 2017 meetings and approved the proposal unanimously at its December 1, 2017 meeting.

I enthusiastically support the curricular change embodied by this proposal and look forward to continue to work with the Faculty Senate regarding this and other initiatives.

Background and support:

The BSL Department Curriculum Committee met on Friday, September 22, 2017 and unanimously recommended to the department's Regular Faculty a revised business law minor that is more appropriate for nonbusiness students. The proposal was distributed to Regular Faculty on 9/29/2017 for their review. The Regular Faculty met on October 6, 2017 and after discussion, unanimously approved the following proposal.

Summary of proposal:

Nonbusiness students seeking the BSL minor should take BUS 202 (Introduction to the Legal Environment of Business) and three additional BSL courses. Business students seeking the BSL minor would continue to take BSL 212, two BSL electives, and the business law capstone BSL 485. The table below depicts the existing minor (which would not change for Business students) and the new minor for nonbusiness students, side by side.

Revision to the Undergraduate Business Law Minor for Non-Business Majors

On December 21, 2017, the School of Business notified my office about revisions to the undergraduate Business Law minor for non-Business majors. Currently the School offers a Business Law minor for Business majors as well as for non-Business majors (academic plan code: BSLW_MN) that share the same curriculum. This proposal is to change the curriculum for non-majors to provide more general, foundational coursework. The current minor (BSLW_MN) will remain the same for Business majors so a new academic plan code will need to be created for the revised minor for non-Business majors.

The current Business Law minor (for both Business and non-Business majors) requires a total of 12 credits including BSL 212 Introduction to Business Law & Ethics, BSL 485 Managing the Legal Factor and two BSL electives. The revised Business Law minor for non-Business majors requires the same number of credit hours but includes BSL 202 Introduction to the Legal Environment of Business and three BSL electives.

The proposed revision does not "represent a significant departure, either in content or method of delivery" from what we are currently approved by SACSCOC to offer since the University is approved to offer undergraduate majors in this area (BBA and BSBA in Legal Studies) and it uses existing courses. SACSCOC only requires notification of program changes that represent a significant departure from our current programs. Therefore, no notification or approval is required for this change.
