Letter of Explanation Curriculum Revisions for Master of Public Health (MPH) Degree

The Graduate Programs in Public Health currently offers a 45-credit master's degree in public health (MPH). The degree was first established at the University in 1982 and has maintained accreditation by the Council on Education for Public Health (CEPH) since it's inception. The MPH degree is a professional degree for students who require a broad general academic experience in public health. Students acquire competency in the fundamental public health disciplines: biostatistics, epidemiology, environmental health sciences, health services administration/health economics, and social and behavioral sciences. The curriculum requirements currently include 19 credits of core coursework, 20 credits of elective coursework and 6 credits for the capstone/culminating experience.

The public health accreditation body, CEPH, has recently revised their accreditation criteria for MPH degrees (2016 version), with a focus on competency-based public health education. The 2016 criteria require all MPH degrees to demonstrate students attain foundational public health knowledge, foundational public health competencies, and degree concentration competencies. In completing the curriculum mapping and activity assessment for meeting CEPH criteria, the generalist MPH currently offered must be revised to specify a generalist concentration course grouping. The Graduate Programs administration has selected a concentration course grouping from existing courses, focused on public health skills development. The concentration course grouping includes 9 credits, which when required, will reduce the number of elective

credits each student will complete. The core curriculum (19 credits),

capstone/culminating experience (6 credits) and total number of credits to earn the

degree (45 credits) remain unchanged, only the elective number of credits is reduced

from 20 credits to 11 credits to accommodate the 9 credit concentration requirement.

The generalist concentration course grouping includes 9 credits of coursework from the

following course titles:

*EPH 644 Program Evaluation or EPH 656 Qualitative Research Methods (3 credits)

*EPH 602 Medical Biostatistics II or BST 625 Statistical Computing (3 credits)

*EPH 607 Interdisciplinary Health Communication (3 credits)

Students may select one of two class titles for the methodology skills requirement and

for the computation skills requirements, and all students complete the final skills course

in health communication. EPH 644/EPH 656 and EPH 602/BST 625 are established

class offerings in CaneLink and the course title and content of EPH 607 will be revised

(previously titled Scientific Communication) to meet CEPH criteria. New faculty hires

are not required to implement the outlined curriculum changes.

*EPH 602 Medical Biostatistics II or BST 625 Statistical Computing (3 credits)

*EPH 607 Interdisciplinary Health Communication (3 credits)

Elective Coursework (11 credits)

Graduate level coursework, public health appropriate, selected by the student

Capstone/Culminating Experience (6 credits)

*EPH 680 Public Health Field Experience (3 cr)

*EPH 681 Capstone Project (3 cr)

The Graduate Programs in Public Health is required to demonstrate competency compliance, including any necessary curriculum changes, with CEPH by January 9, 2019. Implementation of the new curriculum is expected for Fall 2018.

Dear Dr. Rao,

On behalf of the University of Miami, Leonard M. Miller School of Medicine (UMMSM), I wish to express my support for the Department of Public Health Sciences, Graduate Programs in Public Health and its proposed curriculum changes to strengthen the Master of Public Health degree program. I am aware that the Office of Assessment and Accreditation (OAA) has reviewed the proposed changes and determined notification and approval from SACSCOC is not required.

The proposed curriculum changes are in response to 2016 criteria revisions from the Council on Education in Public Health (CEPH), the national accrediting body for public health degrees. Through extensive review in curriculum mapping and activity assessment, the Graduate Programs has proposed revisions to the degree requirements which include a generalist concentration course grouping of 9 credits, which when required, will reduce the number of elective credits each student completes. The generalist concentration course grouping was selected from existing courses, focused on public health skills development. The proposed curriculum changes do not extend the total number of credits required to earn the degree and do not extend the time necessary or cost to the student to complete the degree program. The modification to elective coursework will allow the program to focus on competency-based public health education.

You have my full support in your efforts.

Change in Degree Requirements for the Master of Pubic Health (MPH)

The Graduate Programs in Public Health, with the Department of Public Health Sciences, currently offers a 45-credit master's degree in public health (MPH). The degree was first established at the University in 1982 and has maintained accreditation by the Council on Education in Public Health (CEPH) since it's inception. Changes in the CEPH accreditation criteria (2016 version), with a focus on competency-based public health education, prompted extensive review of the current degree requirements and requires revision to the generalist degree to include additional coursework on public health skills development.

The current degree requirements for the MPH are composed of 19 credit hours of required core courses, 20 credit hours of electives, and 6 credit hours of required capstone/culminating experience for a total of 45 credit hours. The proposed revisions would add 9 credit hours of a required generalist concentration and reduce electives to 11 credit hours. The other degree requirements will remain the same.

The proposed generalist concentration will require successful completion of the following courses: 1) EPH 644 Program Evaluation or EPH 656 Qualitative Research Methods; 2) EPH 602 Medical Biostatistics II or BST 625 Statistical Computing; and 3) EPH 607 Interdisciplinary Health Communications. All of these courses are currently offered in the Graduate Programs course catalog. However the course title and content of EPH 607 will be revised to meet Council on Education and Public Health (CEPH) criteria.

The proposed curriculum changes have been reviewed and approved by the Department of Public Health Sciences (in both the Department Executive Committee and Graduate Executive Policy Committee) and have been presented to all department faculty. Per memorandum from the University Office of Assessment and Accreditation, the proposed revisions do not represent a significant departure, either in content or method of delivery, and notification/approval to SACSCOC in not required. To complete the University review and approval process with the Graduate Council, General Welfare Committee and Faculty Senate, this memo is being provided to indicate approval from the faculty of the Department of Public Health Sciences.

Change in Degree Requirements for MPH

On February 19, 2018, the Miller School of Medicine notified my office of its intent to revise the degree requirements for the Master of Public Health (MPH) effective Fall 2018. These revisions are being made to comply with program accreditation requirements of the Council on Education for Public Health (CEPH).

The current degree requirements for the MPH are composed of 19 credit hours of required core courses, 20 credit hours of electives, and 6 credit hours of required capstone/culminating experience for a total of 45 credit hours. The proposed revisions would add 9 credit hours of a required generalist concentration and reduce electives to 11 credit hours. The other degree requirements will remain the same.

The proposed generalist concentration will require successful completion of the following courses: 1) EPH 644 Program Evaluation or EPH 656 Qualitative Research Methods; 2) EPH 602 Medical Biostatistics or BST 625 Statistical Computing; and 3) EPH 607 Interdisciplinary Health Communications. All of these courses are currently offered. However, the course title and content of EPH 607 will be revised to meet CEPH criteria.

The proposed revisions do not "represent a significant departure, either in content or method of delivery" from what we are currently approved by SACSCOC to offer due to the following:

- The revised program meets the SACSCOC requirement of a minimum of 30 credit hours for a graduate program.
- No new courses are being added. One course will be revised but this only represents 7% of the program curriculum.
- The majority of the program will not be offered via distance education and, in any case, the University is approved to offer 100% distance education programs.
- The program will be offered on the University's Medical Campus.
- The graduate program covers the literature in the field through its required core coursework.
- The graduate program ensures ongoing student engagement in research through a required capstone/culminating experience.

SACSCOC only requires notification of program changes that represent a significant departure from our current programs. Therefore, no notification or approval is required for this change.
