Executive Summary:

The Master of Public Policy (MPP) is a new graduate professional degree proposed by the Department of Political Science in the College of Arts & Sciences. In contrast to our existing Master of Public Administration (MPA) degree, the MPP degree has a deeper focus on the development and effects of public policy, the use of quantitative analysis, the role of economic factors in public-decision making, resource allocation, and decision modeling. Building on the successful curriculum of our online and on campus MPA program, adding the MPP degree to the Department of Political Science's catalog will continue to propel us into the ranks of preeminence among peer institutions that also offer both MPA and MPP degrees. A successful MPP program will require collaboration between the Department of Political Science, other disciplines with a stake in public policy, and the College of Arts and Sciences to ensure that we best utilize our current resources, draw on the existing strengths of the university and its faculty, and strategically add faculty to develop a MPP program fitting for a hemispheric university.

On January 18, 2019, the College of Arts and Sciences notified my office of its intent to offer a new Master of Public Policy (MPP) degree with six tracks and an embedded graduate Certificate in Public Policy effective Fall 2020.

The proposed MPP program will require successful completion of 48 credit hours that include 24 credit hours in required courses, 15 credit hours of a specialization track, 9 credit hours of approved electives, and a required internship or applied project (3 credit hours). Students will be required to choose one of six tracks in the program: 1) Public Management and Leadership; 2) Analytics; 3) Foreign Policy and Security; 4) Health and Social Policy; 5) Environmental and Sustainability Policy; and 6) individualized track. Students may pursue the individualized track only with approval of the faculty advisor.

The program will be overseen by Dr. Jonathan West, Professor of Political Science in the College of Arts and Sciences. Dr. West has a Ph.D. in Politics and Public Affairs from Northwestern University. The title of his doctoral dissertation was "The Scope and Impact of Collective Negotiations in Selected Urban and Suburban School Systems: Implications for Public Policy." In addition, two new full-time faculty positions will be created to support the program and teach the new courses.

The MPP and certificate program will be offered on the Coral Gables campus through traditional classroom instruction. An online version of the programs may be developed in the future. Please note that this will require separate approval prior to implementation. A full proposal will have to be approved by the Graduate Council and Faculty Senate.

The proposed new program does not "represent a significant departure, either in content or method of delivery" from what we are currently approved by SACSCOC to offer due to the following:

- The proposed program meets the SACSCOC requirement of a minimum of 30 credit hours for a graduate program.
- Although five new courses are being created for the program, they do not represent new
 content area and the majority of the program involves repackaging existing courses across
 schools.
- Two new faculty positions will be created to support the program but these are needed primarily for capacity rather than new expertise.
- The program will be coordinated by a qualified faculty member, Dr. Jonathan West.
- The University is currently approved to offer the following graduate programs in related areas:
 - o MA in International Administration
 - MA in International Studies
 - o Master of Public Administration
 - PhD in International Studies
- The majority of the program will not be offered via distance education and, in any case, the University is approved to offer 100% distance education programs.
- The program will be offered on the University's Coral Gables campus.
- The graduate program covers the literature in the field through its required core coursework.
- The graduate program ensures ongoing student engagement in research and/or appropriate professional practice and training experiences through either a required internship or applied project.

1. RATIONALE

a. Exact Degree Title.

The College of Arts & Sciences' Department of Political Science seeks to offer a master's degree program titled the Master of Public Policy (MPP).

b. Purpose and Goals of the Degree.

The Master of Public Policy (MPP) is a professional degree that provides students with core skills in economics, policy analysis, and ethics. Similar to our existing MPA, the MPP program will help students to synthesize their college education, volunteer work, and professional experiences into a career where it is possible to "make a difference" in a wide variety of leadership positions in government agencies (local, state or federal); nonprofits, and the international and private sectors (NASPAA).

The MPP degree stresses the research, analysis and evaluation of various public issues (e.g., social, global, economic, health) to develop effective policy solutions. In general, MPP programs give great attention to policy formulation, analysis and evaluation. Though MPP programs typically have a strong focus on the development and use of quantitative analysis skills to assess public policy alternatives, curricula recently begun to include some coursework in management, given the growing recognition that the implementation process can benefit from policy analysis and vice versa (NASPAA).

Coursework in the MPP includes required core courses, concentration or specialization courses, and an internship or practicum for pre-service students. MPP programs usually take two years to complete. MPP programs usually offer core courses in economics and policy analysis, finance and budgeting, policy process, and research methods. MPP programs specifically emphasize economics, policy analysis, quantitative methods, and the policy process. While our existing

MPA program gives greater attention to public management, organizational behavior and human resource management, because there is a natural overlap between some courses within the MPP and MPA programs, many peer institutions offer both degree programs. We seek to join our peers in offering both the MPA and MPP degree within the Department of Political Science.

MPP programs are traditionally interdisciplinary, drawing on coursework in such fields as economics, public health, anthropology, sociology, and environmental studies. Elective courses in the proposed MPP program reflect the breadth and depth of the College of Arts & Sciences' social science offerings, as well as courses offered by our colleagues at the School of Communication, the School of Education and Human Development, the School of Nursing and Health Studies, the Miami Business School, the Leonard M. Miller School of Medicine, the UM Law School, the Rosentiel School of Marine and Atmospheric Sciences, and the Abess Center for Ecosystem Science and Policy.

2. CURRICULUM

a. Major divisions of the field in which graduate degree work will be offered.

The Department of Political Science will administer the MPP program, provide advising support, and offer core courses. Existing program staff that administer the MPA degree will be tasked with the administration of the MPP program. Additional specialization and elective courses may be taken in the Department of Sociology, the Department of Anthropology, the Miami Business School, the School of Nursing and Health Studies, The School of Education and Human Development, the Rosentiel School of Marine and Atmospheric Sciences, the School of Architecture, the Leonard M. Miller School of Medicine, the UM Law School, the School of Public Health, the Ecosystem Science and Policy program, and the Master of Arts in International Administration program.

b. Description of the proposed program.

The proposed Master's program requires the completion of 48 graduate credits, and the program includes a core curriculum (24 hours), a specialization track (15 hours), approved elective credits (6 hours), and completion of an internship or applied project (3 hours). Each student can customize the elective courses and specialization track in consultation with the faculty advisor to ensure that he/she meets his/her professional goals and objectives. The program is structured to be completed in two years, but could be done in 18 months. Students may also obtain a Certificate in Public Policy by completing 18 credits of the program's core courses. Full course descriptions are provided in Appendix 4.

e. Electives (2 courses, 6 credits)

Students will select from a wide variety of courses, including some offered within the Department of Political Science and others from across the University of Miami. Students will select courses based on their interest and professional goals. A list of possible outside-the-department courses is provided in Appendix 2.

f. Internship of Applied Capstone Project (1 course, 3 credits)

Students will work with the Department's internship coordinator to find a suitable placement consistent with their career goals. Student interns must complete 200 hours to obtain 3 credits. A 30-page analytical report and daily diary is required of MPP interns. The applied project would involve students working individually or in teams with a client where they gather data about a problem the client is facing, analyze the problem, and suggest policy solutions in an analytical report for presentation to the client. The option of an applied project requires approval of the internship coordinator and the supervising faculty member.

3. ADMISSIONS REQUIREMENTS

In cooperation with the College of Arts and Science, the Department of Political Science will review applicant files and make admissions decisions.

a. Requirements for Admission Include:

- Completion of an application
- A baccalaureate degree from an accredited institution
- A cumulative undergraduate GPA of 3.0. (In order to limit class size for maximum teacher-student exchange, the MPP program will give preference to

- students with above average GRE scores, excellent letters of recommendation, and superior writing skills).
- GRE minimum combined score (verbal and quantitative) of 279. The Graduate School has occasionally provided waivers for exceptional cases.
- Two letters of recommendation
- b. Admissions Requirements for the Certificate in Public Policy Include:
- Completion of an application
- A baccalaureate degree from an accredited institution
- Students not meeting the minimum admission requirements for the MPP program may seek admission to the certificate program, and after successful completion of 18 credits from the core courses of the MPP program, with a grade of B or higher in all courses, will be accepted into the MPP as a degree-seeking student. (See Appendix 3, Admission Rubric for Certificate in Public Policy).

4. STUDENTS

Students are likely to come from a range of backgrounds including political science, biology, psychology, and international studies. We will aim to recruit pre-service as well as young- and mid-career professionals from the U.S., Latin America and the Caribbean and other parts of the world who wish to develop their quantitative and qualitative analytical skills. The program will have its first cohort in the Fall of 2020. The target enrollment for the program launch in the Fall of 2020 is 10 to 15 students, with the program expanding to 15 to 20 students by Fall of 2022. Once the traditional on-campus program is fully established, we will seek to create an online version of the program.

5. RESOURCES

a. Assessment of Library Holdings

The University of Miami Library system has an extensive collection of materials related to public policy that will be accessible to students in this program.

b. Physical Resources: Existing Facilities, Equipment, and Space

Classroom facilities to support graduate student-driven research are already in place or are being developed for the Department of Political Science. The existing space and equipment will meet the needs of the new graduate program. While we do not expect to request any additional space in the foreseeable future, as the program's enrollments grow, if more than two tenure-track faculty with a focus in public policy are housed within the Department of Political Science, there may be a need for additional office space.

c. Additional Faculty

The majority of the core and specialization courses required for the MPP are already on the books. A total of five new courses require development. To this end, the College of Arts and Sciences has approved one new tenure-track line that will start employment in AY 2019-2020 to launch the program. We anticipate a second new tenure-track line will start employment in AY 2020-2021. Full-time POL faculty will teach the remainder of the proposed core courses of the program, and some of the specialization courses. We will also work with faculty in other schools and departments who will offer some of the specialization courses. Required MPP courses are shown in *bold italics*. Additional courses included in the specialization tracks or as electives are listed for each faculty member. For some of our courses, two or more faculty members currently teach them.

At present, the department has four faculty who teach statistics and quantitative methods, and one new full professor hire with a pending offer (as of 3/1/19). Of the 18 POL faculty involved in this program, only three are lecturers, and two of those three are Senior Lecturers who have been at UM for many years. With regards to economics, POL has an existing faculty member and a new hire, beginning in the fall (Dr. Xui Gao) with strong economics and public policy backgrounds, including degrees in Public Policy, and a TT faculty member who teaches International Policy Economy (IPE). Dr. Gao is a new TT hire who will teach Microeconomics in Public Policy and Macroeconomics in Public Policy. Nine TT and NTT existing POL faculty can guide research and scholarly activity related to Public Policy. Six additional POL faculty can mentor research in their subfields. We have been authorized to hire one additional TT faculty to begin in 2020-21.

d. Budget

The College of Arts and Sciences approved two new faculty lines to support this program. Dr. Xui Gao has accepted an offer and will be joining the POL Department as an assistant professor in Fall 2019. One additional tenure-track faculty hire in the field of public policy with employment starting in the Fall of 2020 will be necessary to make the program feasible. These two tenure-track faculty hires will, together, teach 6 - 8 MPP courses within the department of political science per academic year. These two new faculty in the field of public policy will also be responsible for developing four of the new courses in the MPP curriculum. Relatedly, in order to have enough open seats in existing courses for newly enrolled MPP students to enroll in the courses that count towards both the MPA and MPP programs, the Department of Political Science will also request one tenure-track faculty hire with employment starting in the Fall of 2020 to replace an MPA faculty member departing the university effective December 2018. We do not anticipate any additional building, equipment, or space will be required. In addition, no new staff with be required, as existing MPA/POL support staff with administer this degree.

Appendix 4: Full Course Descriptions

POL 601. Budgeting and Financial Management and Administration

Role of the budget in shaping public policy; managing public revenues; budgetary theory, politics, and fiscal management. We study examples from state, municipal and federal governments.

POL 6XX. Introduction to Research Design, Data Collection and Survey Research

In addition to discussing general questions about the philosophy of science, we will cover fundamental issues such as arriving at a research question, theory building, hypothesis development, variable measurement, identifying and dealing with confounding factors, and causality, for both quantitative and qualitative analysis. We will also discuss Principles of survey construction and validation; format selection, sampling, question wording, adaptation for international audiences, response option formats, and question order.

POL 610. Statistics for Politics and Public Administration

This course focuses on the use of statistics to conduct quantitative research (i.e., statistics) in political science, policy, and public administration. Includes applied multivariate statistics in support of policy and management problem solving. The course emphasizes hands-on data work, including the estimation of regression models. Students will learn how to perform analysis using existing data sets and how to present findings in an appropriate manner. Statistical analysis software will be used and is required for all students.

POL 6XX. Microeconomics for Public Policy

Microeconomic theory as applied to policy making, concepts of efficiency. Microeconomic analysis and modeling to incorporate market failure and issues of uncertainty and information failure; organization models; policy instruments; policy and planning applications.

POL 6XX. Macroeconomics for Public Policy

This course examines the working of the aggregate economy. It aims to understand the key determinants of business cycle fluctuations and of long-run economic development. This includes coverage of the role of employment, productivity, trade and fiscal deficits, inflation, and interest rates. The emphasis of the course is on the impact of monetary and fiscal policies on the macro economy. Students will be able to analyze and discuss important current economic issues, such as government spending and tax reforms, Social Security reforms, the conduct of monetary policy, and the impact of changing economic

conditions around the world.

POL 625. Comparative Public Policy and Implementation

Comparison and analysis of the organizational and managerial policy problems of developed and developing nations. The administrative process will be considered within the institutional and cultural framework of each nation. Case studies will be used to focus on transition from traditional to modern techniques of public management.

POL 634. Applied Policy Analysis

Examines a variety of policy problems through the framework of problem definition, formulation of alternatives, assessment of alternatives, and policy impact evaluation. Students will also be introduced to cost-benefit analysis and evaluation methods.

POL 646. Public Policy Process and Implementation

An introduction to the stages through which public problems are recognized and considered as part of the political process, and how policies to address public problems are formulated, implemented, and evaluated. The course examines theories and frameworks that allow us to better understand the policy making process in the United States and in other countries. The course includes an examination of how political practices, institutions, and stakeholders influence agenda setting, the development and selection of policy alternatives, the selection of policies, and the their impacts on society.

POL 606. Organizational Dynamics and Management

Organizational dynamics and management in public and non-profit organizations. Focus on organizational theories, leadership, behavior, goals, effectiveness, and change, with an emphasis on the distinctiveness of public organizations, public-private partnerships, new public management, and digital governance.

POL 624. Nonprofit Organizations: Law, Policy, and Management

This course teaches students the essential requirements for creation and operation of taxexempt nonprofit organization in accordance with state and federal law. The course covers a wide range of relevant topics including guidelines for charitable giving and charitable solicitation, pitfalls that can result in personal liability for officers and directors, and statutory constraints on legislative lobbying and political activities.

POL 626. Administrative Law

Administrative law is the study of the legal relationship of government agencies to

legislatures, courts, and private parties. The course examines the legal dimensions of bureaucratic power and procedures as well as constitutional and statutory constraints on regulators and administrators. Topics include rule making, adjudication, investigation and enforcement, political controls on agencies, judicial review of agency decisions, governmental liability and immunity, public records and open meetings laws. Both federal law and Florida law are covered. The course assumes a basic knowledge of the American legal system, constitutional law and bureaucracy.

POL 647. Human Resource Management in Public Service

Topics include human resource management in public service: job analysis and design, evaluation and appraisal, recruitment and interviewing, training and development, wages and benefits, and health and safety. Unionization, regulation of wages, hours and working conditions, financial security for workers, and job anti-discrimination legislation are considered.

POL 651. Productivity Improvement in the Public and Nonprofit Sectors

Definitions and measures of productivity. Evaluation of government programs, and methods of productivity improvement.

POL 657. Ethical and Managerial Issues in Government, Business and Nonprofit Organizations

Governments at all levels in this country—national, state, and local have encountered scandals involving ethical wrongdoing. Businesses and nonprofit organizations have faced similar problems. Countless examples of unethical and ethical behavior occur in organizations daily. This course examines the causes and consequences of such actions and the managerial strategies and competencies needed to effectively cope with the ethical issues confronting individuals and organizations.

POL 658. From Electronic Government to Digital Governance

Graduate and advanced undergraduate seminar explores the transition from electronic government to digital or d-governance, emphasizing political participation, citizen-centric public administration and the proliferation of global information technologies and social

POL 6XX. Cost-Benefit Analysis and Public Policy

The goals of this course include learning (1) how to read, or judge, a cost-benefit analysis; (2) how to incorporate elements of cost-benefit analysis into policy work; and (3) when CBA is a good tool to use and when it isn't. This class also presents an opportunity to reflect on big picture issues of how to treat uncertainty and risk; discount costs and benefits received in the future; value lives saved; and manage other difficult matters. In brief, this class offers a comprehensive treatment of the cost benefit analysis

methodology, with attention devoted to the microeconomic underpinnings of the technique as well as applications drawn from many areas, including health, the environment, and public goods.

POL 616. Experiments in Political Science

Examines experimental method of hypothesis testing, with specific examples in the study of politics.

POL 617. Introductory Statistical Methods in Political Science

The tools needed to manipulate and analyze quantitative data rigorously so you may answer questions of political interest. First in a two-course sequence.

POL 618. Advanced Statistical Methods in Political Science.

The maximum likelihood framework for statistical inference in the study of politics. Second in a two-course sequence.

POL 619. Introduction to Game Theory for Political Science

The rudiments of non-cooperative game theory. Mainly intended for political science students, but presents applications from other academic disciplines such as economics, business administration, sociology, and psychology.

SOC. 613. Qualitative Research Methods

In-depth introduction to qualitative, inductive methods, with emphases on grounded theory and action research. Focus on qualitative interviewing (including focus groups) and participant observation for the collection of data in naturalistic social settings, with simultaneous data analysis; qualitative methods in mixed-methods research introduced. Covers ties between methods and theory, additional basic methods used in qualitative research, and typical analytic approaches; touch on more esoteric methods; study current issues and debates relevant to this set of approaches to generating knowledge.

GEG 691. Geographic Information Systems I

An introduction to fundamental concepts in Geographic Information Systems (GIS) and related geographic technologies. Students are exposed to leading GIS software tools used in the industry.

GEG 693. Geographic Information Systems II

An introduction to spatial analysis, which consists of techniques for analyzing patterns of and interrelationships between spatial data. Topics include vector polygon editing and topology, integration of raster and vector data, surface analysis and 30 analysis, suitability mapping, spatial modeling and multi-criteria evaluations.

POL 611. Security in the Arabian Peninsula

Examines how local and international actors build sustainable peace strategically through peace-keeping, peace accords, reconciliation, education, human rights, international law, and state-building.

POL 630. Intelligence and National Security

This course will study the US national security community structure and decision making process. The course will look at the National Security Council, the principal national security agencies (such as the CIA, Defense Department, and State Department), how they interact, and their roles in dividing and executing policy. We will also examine the role and function of senior policy decision makers such as the President. We will study recent policy challenges such as Iraq and Afghanistan as examples of National Security policy.

POL 644. Chinese Foreign Policy

International relations of the People's Republic of China, in theory and in practice. Structure and context of foreign policy decision-making; domestic influences on the foreign policy making process. China as a global and regional actor.

POL 677. Security in South Asia

The security system of South Asia's northern reaches and the current conflict involving Afghanistan, Pakistan, and India: considerations of sovereignty and the role of frontiers in world politics.

POL 6XX: Global Trade

Topics: the theory of comparative advantage. Trade, foreign policy, and development. Arguments for and against trade protection. History and development of trade agreements. Trade dispute resolution. Domestic politics of trade, including mitigating the costs of trade dislocation. Use of sanctions as a tool of foreign policy.

POL 691. International Security

Analysis and evaluation of approaches to international conflict, resolution, reduction and stabilization such as international organization, law, collective security, balance of power, functionalism, world government, morality, and conscience. Special emphasis on recent problems and efforts at institutionalizing social control.

POL 693. International Relations of the Middle East

Regional and inter-regional analysis of the foreign relations of Middle Eastern nations, domestic and geopolitical factors.

POL 694. European Security

Examines regional security in Europe, focusing on NATO expansion, EU expansion, Russian foreign policy and related issues.

POL 605 Comparative Family Policies: Sex, Babies, and the State

In one of the most profound revolutions of the past century, gender roles have irreversibly changed and equal rights for women and men has become a stated goal in western societies, even if not the reality. This course examines policies on reproduction, work and the family in advanced industrialized countries including Latin American Countries.

POL 636. U.S. Health Care Crisis: Politics and Policies

This seminar will explore the politics and policies of healthcare in the United States. Our examination of the current crisis in cost and coverage will draw on experience from the debates on comprehensive and incremental reform over the past decade. In addition, we will explore the politics and policies of other health and science issues. Students will be expected to attend every class and be actively involved in class discussions. There will be two examinations, one at mid-term and a final based on readings and course discussions.

POL 655 Public Policy and Health

Development of public policy at the federal, state and local level. Policy process, models of policy analysis, policy development in several government service areas, and plans for policy change. Special emphasis on health policy formulation, implementation and the use of epidemiological tools in health policy analysis.

POL 682. Political Economy of Development

Overview of the principal theoretical paradigms of the development process Comparative analysis of issues such as the role of the state, strategies of industrialization, changes in social structure, basic needs and the trade-offs between growth and equity.

POL 669 LGBTI Politics

Describes and explains global variance in government policies of interest to lesbian, gay, bisexual, transgender and intersex citizens including sodomy laws, anti-discrimination ordinances, same-sex marriage and adoption, military service, and the right to change one's sex or identify as neither male nor female.

HSM 601. Essentials of Health Care Administration

This course will allow the student to understand the health care system, including physician services, hospital and hospital systems, long-term care providers, mental health services, and pharmaceutical services. Health care labor markets will be examined. Various elements associated with the financing of health services will be analyzed as well including indemnity insurance, capitation, and the role of managed care, accountable care organizations, and consumer driven health care in theory and practice. The role of government and its impact on our health care system will be understood as well. Alternative health care systems looked at from a global perspective will be analyzed, and possible application to the U.S. health care system will be evaluated.

HSM 655. Public Policy and Health

Role of public and private institution in health promotion, health care delivery, and health insurance. Explains how and why government and society attempt to influence health-related behaviors and the resulting effects on individual's lives.

INS 672. Global Public Health Policy and Ethics

US Foreign Policy & Global Public Health Focus on Infectious Diseases: Diplomacy, Security & Ethical Challenges. National, regional and global health policies with special consideration to ethical and human rights issues; policies and the moral considerations that shape public health policy.

ACC 665. Health Care Financial and Managerial Accounting

This course covers managerial and financial accounting concepts applied to health care organizations. Topics include cost allocation and management control systems.

HSM 684. Analysis of Health Care Delivery and Policy

All societies must deal with the allocation of scarce resources. In our society, primary reliance is placed on markets and prices. Since most students are unfamiliar with the methods of decision-making from a manager's perspective, we will discuss criteria to evaluate the allocation of resources and analyze the behavior of two of the principal actors – consumers and firms. A careful analysis of the choices made by individuals, organizations, and governments will demonstrate that sensible "choice architecture" can successfully nudge people toward better decisions without restricting their freedom of choice. The principles of economic and management decision-making will be presented in the context of health care systems and markets. We will use numerous real-world issues and case studies to demonstrate decision-making techniques, especially for health care organizations and consumers.

POL 631. Global Environmental Politics

Examination of the environment within the context of economic globalization. Contrasts the international trading regime and those regimes designed to protect the environment, with specific attention to the issues of global warming and bio-diversity.

POL 645. Environmental Policy Making

Examination of different ethical approaches to the environment; the federal government's management of natural resources; selected environmental policies; international environmental policy issues. Topics include federal management of national grazing lands, national forests, and minerals in the public domain. Analyzes environmental policies such as air, water, toxic wastes, energy, and environmentally-related issues in international trade and national security.

POL 653. The Environmental Movement: Groups, Beliefs and Values

Exploration of the origins and political impact of environmentalism in the United States and, to a lesser extent, in the global context. Impact of democratic participation on environmental politics.

IGS 644. Energy Security and Environmental Sustainability

The concepts of environmental sustainability and energy security will be explored. The importance of energy and the mitigation of climate change in formulation of country strategies, advancement of national interests and shaping of the international system will be stressed.

MES 620. Environmental Law

An introductory course focusing on environmental problems. The study of Regulatory legislation, common law, and administrative law. Topics include toxic substances, air and water pollution, and habitat and species protection.

MES 720. Coastal Law and Policy

Course examines the authority of different levels and agencies of government to make decisions affecting the coastal zone. Course also explores the coastal problems of shoreline use and development, uses of water areas and the seabed, and the related questions of environmental protection.

MES 616. Ocean Policy and Development and Analysis

Ocean policy development and analysis of issues such as: offshore oil drilling, fisheries resource conflicts, marine mammal protection, ocean dumping and incineration, multiple use conflicts in marine protected areas, pollution from land based sources, and oil spill contingency planning.

RSM. 620 Climate and Society

This course is designed to provide students from different disciplinary backgrounds with an overview of physical processes, general concepts and policy debates surrounding climate issues.
