GRE Score

<u>GRE</u> scores are only valid for a period of five years. The Frost School of Music Graduate program requires a minimum 295 combined Verbal and Quantitative score and minimum 4.0 on the Analytical Writing. The GRE codes for UM are as follows: *Institution Code R5815*, *Department Code 2404*

TOEFL/IELTS Score

Test scores are required for international applicants whose native language is not English and who have not received a degree from an accredited English-speaking institution. Additional information can be found on <u>International Applicants</u>.

<u>TOEFL</u> and <u>IELTS</u> scores are only valid for a period of two years. The Frost School of Music requires applicants to receive a minimum TOEFL score of 80 or a minimum IELTS score of 6.5. The TOEFL codes for UM are as follows: *Institution Code R5815*, *Department Code 2404*

COURSE CHANGES:

FIRST REVISION

Change the course name of MTC 715 from "Composition Seminar" to "Graduate Composition."

Rationale:

composition courses names in line with the undergraduate course names (UG courses are called "Composition"). Impact: This change will affect MM and DMA in Composition, and MSJ in that all three degrees require MTC 715. The impact however, will only be that the names of the course in the degree listing in the bulletin will need to be changed.

SECOND REVISION

Eliminate MTC 716 and change MTC 715 to be a repeatable course (repeatable up to six times).

Rationale: The course number implies that there is a sequential instruction (i.e. MTC 716 would expand on what was presented in MTC 715); however, the course number merely distinguishes that MTC 715 is offered in the fall and MTC 716 is offered in the spring. The course number has nothing to do with the material in the course. For example, students can begin with MTC 716 before taking MTC 715.

Impact: This change would require that the degree descriptions for MTC and MSJ graduate degrees change MTC 716 to MTC 715.

THIRD REVISION

Change the course name for MTC 667 "Electronic and Computer Music Seminar" to "Graduate Composition and Technologies" and change the course name for MTC 767 "Advanced Electronic and Computer Music Seminar" to "Advanced Graduate Composition and Technologies"

Rationale: the nature of the course will be clearer on the transcript and in the bulletin.

Impact: The change will require edits to be made in bulletin

DEGREE REQUIREMENT CHANGES:

FIRST REVISION

Current Requirement: Students are required to take 4 credits in composition lessons: MTC 715 Composition Seminar I and MTC 716 Composition Seminar II and 6 credits in MTC 810 Masters Thesis. The total number of "Composition" credits is 10.

Revised Requirement: Students are required to take 4 credits in composition lessons chosen from MTC 715 Graduate Composition and/or MTC 667 Graduate Composition and Technologies and/or MTC 767 Advanced Graduate Composition and Technologies and 6 credits in MTC 810 Masters Thesis. The total number of "Composition" credits is 10.

Rationale: MTC 716 has been replaced by a repeat of MTC 715 (see above) and the title for MTC 715 has been changed (see earlier document submitted to graduate council). The rationale for adding the option of MTC 667 and MTC 767 to the list of composition courses is to allow students in the Master of Composition degree to include composing exclusively with music technology (which is what takes place in MTC 667 and MTC 767) if they choose to do so. While students pursuing the MM in Composition may focus on music technology within the MTC 715 (Graduate Composition) course, it is not clear to the student from looking at the bulletin that it is possible to do so, and this change will bring clarity to the student's transcript as it will better describe the nature of the work of the student.

Impact: MTC 667 and MTC 767 are already being offered. Allowing the student to take this in lieu of MTC 715 will have little impact on the load off faculty because it would simply be substituting one course for another and will often involve the same professor. Also, it should be noted that this would involve 1 or 2 students in any given year. No new sections will need to be added to the curriculum.

2ECOND KEAI2ION

Current Requirement: The student must select two of the following: MTC 711 Theory Pedagogy, MTC 713 Twentieth Century Idioms, MTC 717 Analytical Techniques; and three credits of Approved Electives in MTC (total of 9 credits).

Revised Requirement: The student must take MTC 711 Theory Pedagogy, 3 credits in a Graduate Level Music Technology Course (such as MTC 605, 606, 621, 705, 767) approved by the advisor and 3 credits of Approved Electives in MTC (total of 9 credits)

Rationale:

All students should gain experience in teaching theory, especially at the Frost School with its innovative Experiential Music Curriculum and therefore, the MTC department feels that MTC 711 should be a required course rather than an elective course.

It is crucial that a composition student gains knowledge and training in music technology. The majority of academic jobs ask for candidates with experience in music technology. Students entering this degree have a wide variety of interests and background in music technology so flexibility in course choices to fulfill this requirement is appropriate.

The department feels that it has many courses that will be beneficial to the graduate composition student and that the requirement that the student choose either MTC 717 or MTC 713 to satisfy the theory requirement is not necessary nor beneficial to the student. Thus that portion of the current requirement has been changed to be an MTC elective.

Impact of Change: This change will have little impact on enrollments. Currently, in the advising process students are already being guided to take Theory Pedagogy and courses in Music Technology. There will be no new courses offered as a result of this change and the potential enrollment increases will be negligible.

THIRD REVISION

Current Requirement: The student must take MCY 624 Contemporary Music and three credits in Music History Electives

Revised Requirement: The student must take six credits of Approved Electives in MCY.

Rationale: The department feels that the Musicology Department (MCY) offers many courses that will be beneficial to the graduate composition student and that the requirement that the student choose specifically to take MCY 624 to satisfy the musicology requirement is not necessary nor beneficial to the student. Thus, that portion of the current requirement has been changed to be an MCY elective.

Impact: This would have almost no impact on Musicology as it would only change enrollment in MCY 624 by one or two students per year, or may not change the enrollment at all as it will still be a desired course for the graduate composition student.

Impact on Faculty Load: None. No new courses are being created. No additional courses/sections will need to be offered.

Impact on Classroom demands: None. No new courses are being created. No additional courses/sections will need to be offered.

FOURTH REVISION:

Current Requirement: Students must take 2 credits in Applied Lessons and 2 credits in Approved Ensembles.

Revised Requirement: Students must take 4 credits in Applied Lessons, Ensembles, or Conducting, in any combination.

Rationale: Students arrive with varving levels of performance ability and background. Sometimes it is https://next-bulletin.miami.edu/courseleaf/approve/

advantageous for them to gain more ensemble experience. Other times it would be best for them to get more conducting experience or applied lesson experience. This change would allow better flexibility to accommodate individual student needs. Impact on Faculty Load: This change may ease the load on the faculty as it will allow more choices to the student to fulfill the requirement. In some cases, where the student chooses to take 4 semesters of applied credit, it could add to the load of the applied faculty, but in the last ten years, there has only been one student who wanted to purse four semesters of applied lessons.
