Candidates for the Doctor of Musical Arts in Choral Conducting at the University of Miami Frost School of Music must possess and demonstrate a gift of musical leadership based upon broad experience with choral ensembles and a strong foundation of skills from previous training. Admission requirements include baccalaureate and masters degrees in music and practical experience in choral conducting through church, school, or community ensembles. Enrollment in this major is only by special permission after completion of the application and audition process.

The mission of the Doctor of Musical Arts in Choral Conducting at the Frost School of Music is to:

Provide a music performance-based education and to train conductors to further develop knowledge and skills on and off the podium

Promote a platform of learning that includes excellence in performance, creativity, artistry, and scholarship

Foster a sense of community involvement in the arts and the greater musical world

This degree combines scholarship with practical concerns in a way that prepares graduates for a diverse life in choral music, whether they choose to focus on an academic career, professional career, or a combination of the two. Emphasis on excellence in conducting and teaching, negotiating the job market, markets, becoming an outstanding clinician and adjudicator, and exploring administrative opportunities has allowed this program to consistently place graduates in outstanding positions throughout the country.

Applicants who are applying with a current degree in progress will be required to have their final transcripts and diploma evaluated upon arrival at the Frost School. If applicants use Josef Silny for the initial evaluation, the Frost School will cover the evaluation. If applicants choose a different vendor, they will be responsible for the cost of the re-evaluation.

Decisions

Students are recommended for admission to the Frost School of Music by the faculty and admission committees. Final acceptance to the Graduate program is made after all materials requested by the Frost School of Music have been received and evaluated. Scholarships and/or Assistantships are awarded based on faculty recommendation.

Admission decisions are sent out starting in late March.

Applicants must be in-progress toward completing or have earned the appropriate prior music degree(s) from a regionally accredited institution in order to apply for a graduate level music program. If you are accepted and decide to attend the Frost School, you will be required to provide a final transcript showing a conferred degree.

The MM in Music Business & Entertainment Industries and the MA in Arts Presenting & Live Entertainment Management do not require prior music degrees. The MS in Music Engineering Technology is open to students who have completed an undergraduate degree in an appropriate engineering/science field.

Rationale

Rationale

1) Increase the amount of private lesson time and credits.

Rationale: Currently, a DMA student receives 4 semesters of lessons, at 1 credit each (total of 4 credits), 30 minutes, once per week. The new degree increases this to 6

credits- the first two semesters remain 1 credit, the final two semesters increase to 2 credits. In current and prospective student interviews, this was one of the first questions and main concerns- they are looking for an increase of one-on-one mentorship time.

2) Increase the amount of podium time in a graduate recital choir/workshop environment through the addition of MVP 784 Chamber Singers.

Rationale: o Private lessons in a one-on-one situation are very useful for students, but the learning in this environment is greatly increased when students are then given the opportunity to put this work into practice with singers and players. In a graduate recital laboratory choir, students focus on gesture and rehearsal skills, with a masterclass instructor in the room able to provide feedback and guidance on the spot. This also serves to aid other students in the ensemble to better understand the process of rehearsal planning and podium skills, useful for all levels of future conductors whether undergraduate or graduate students. o Chamber Singers MVP 784 currently exists in the Bulletin, but with a different description. The course was created by former DCA Jo-Michael Scheibe when he led the program many years ago, and was pulled out of the curriculum at some point and changed into another SATB choral ensemble. The proposal is to keep the title and number of the course, but to return it to its original intent, as a graduate recital choir. This course is also available to the MM students, and will serve as their main ensemble for recitals. Undergraduate students may take the course to fulfill an ensemble credit. o Regarding current trends, almost all graduate choral conducting programs have a graduate recital choir or workshop in their curriculum, and when interviewing students, alumni and prospective students, this is something they felt was highly valuable.

3) Increase the credit number for Choral Literature, MCY 635 and 636

Rationale: o This is considered a cornerstone academic course in most graduate choral conducting programs that I have researched, including the University of North Texas, Cincinnati Conservatory of Music, University of Michigan, Michigan State University, Yale University, University of Southern California, and others. o Our Choral Literature sequence is currently 2 semesters, and 2 credits, which puts our requirements lower than most degree programs in the US. The content of this course is crucial for student understanding of the most important aspect of curriculum design for choral ensembles, their repertoire choices. Choral music dates back to the Medieval period, so a great deal of time is needed to conduct a thorough investigation of this vast body of music. For this reason, we are requesting that these two courses be increased to 3 credits instead of 2. This will also allow for more time for students to digest the material, for the instructor to present current trends in music, and to add a focus on underrepresented composers that have often been left out of the study of the choral canon. o The Chair of MCY, David Ake, said in response to this request of a credit increase, "Yes, absolutely!" (10/20/20)

4) MED 732 Vocal Methods and Materials in Music Education- pull out of required courses, move to elective courses

Rationale: This is an MED course, but is not required in any of the MED degrees. This course has been taught once by Corin Overland, who described it as a "holdover from the degree" that predated his arrival at Frost. It is currently only required of Choral Conducting graduate students, and for that reason, will be difficult to enroll. We would like to propose moving this course from the required to the elective category, so that we can revisit the necessity of this course, and whether it should be redesigned as an MVP course. This shift also allows for those 2 required credits to be added to Choral Literature courses.

5) Allied Music Courses

Private Voice or Piano Study- Change from 4 semesters to 2 semesters.

Rationale: o Currently, the degree requires 4 semesters of either private Voice or Piano study. This is an unusual requirement in comparison to most DMA Choral Conducting degree programs, but my Departmental colleagues and I feel it remains a valuable aspect of our degree. In order to more closely suit the needs of our students, we would like to decrease this requirement to 2 semesters, and allow students to either choose additional semesters of private study, or to take those 2 credits in other non-Choral Studies courses.

Vocal Pedagogy- pull out of required courses, move to elective courses

Rationale: o Currently, the degree requires MVP 638, Vocal Pedagogy. We feel this is a highly valuable course. However, it is offered as a mixed graduate and undergraduate course, and functions at an introductory level for DMA level graduate students. For DMA candidates who have already taken Vocal Pedagogy at another institution, they would have the option to take MVP 738 Advanced Vocal Pedagogy. or another elective outside of the area of Choral Studies in lieu of this course.

Performance Seminars- move from required courses to elective courses

Rationale: o Currently, the degree requires three semesters of Performance Seminars. We feel these are valuable courses. However, if a DMA candidate has taken performance practice courses at another institution, they would have the freedom to elect to take these courses again at D.M.A. in Choral Conducting 4 Frost, or choose other non-Choral Studies courses to enhance their coursework. Additionally, performance practice, as it pertains to the voice and to choral ensembles, is currently incorporated into the Choral Studies curriculum with Score Study, Choral Conducting Workshop Major and Smaller Works, as well as in Applied Conducting and Chamber Singers.

6) Creative Activities- Change from 1 option to 2 options for doctoral project

Rationale: o Many of our competing institutions offering a DMA in Conducting treat this as a performance-based degree, and allow students flexibility in their final project. We feel that all students should develop strong research and writing skills, and that this should be an important aspect of the final project. For students who are focused on building their future academic work through research and publishing, they would choose Option 1: Writing Focus (described below). This would match our current final project, which is a Doctoral Essay. For students who are more focused on building their future work as practicing conductors, performers, and workshop presenters, they could choose Option 2: Performance Focus (described below). This option would more closely match the final projects in Instrumental Conducting and Vocal Performance and Pedagogy DMA degrees here at Frost, as well as DMA Choral Conducting degrees at similar institutions. o Currently, there is a course listed, MED 702 DMA Essay Proposal (1 credit), which is no longer offered. The Department would like to add a course titled MVP 830 Pre-Candidacy DMA Project Preparation (1) that would serve both Choral Conducting DMA students, and Vocal Performance and Pedagogy DMA students, and would serve a similar function as MED 702. o This addition of Option 2 also falls in line with NASM recommendations for final projects within the scope of a degree listed as "DMA" rather than "PhD". o Typically, Corin Overland has received some load credit in the Creative Activities portion of the DMA Final Essay, as he has served to advise students on a one-on-one basis for these. As of now, the plan would be for this course to be taught by Corin Overland (or someone from the MVP Department) as a 1 credit course, and would essentially not change his load. We would ask the course be offered in Fall. o MVP 830: Description: This seminar will guide graduate students in vocal performance, vocal pedagogy, and choral conducting through the initial development stages of a grad

- 7) MVP 772 Choral Conducting Workshop: Major Works o Requested title change. Currently missing the word "Workshop" o Requesting description change. ② Current description: Course focus is placed on major choral-orchestral works with particular emphasis on two or three major works. In addition, conductors preparation for choral-orchestral works, including instrument transportation, score preparation, musical line, historical context, and score marking. are included. ② Description Change: Study of major choral-orchestral works with emphasis on working with an orchestra, historical context, performance practice, interpretation, and gesture.
- 8) MVP 773 Choral Conducting Workshop: Shorter Choral Works o Requested title change. Currently called "smaller", but we feel that title is confusing. o Requesting description change. D.M.A. in Choral Conducting 5 ② Current description: Study of smaller choral works by Poulenc, Hindemith, Ravel, Debussy, Brahms, Mendelssohn, Schubert, Schumann, etc., with emphasis on style, interpretation, and gesture. ② Description Change: Study of shorter choral works by various composers with emphasis on style, performance practice, interpretation, and gesture.

Reviewer Comments **Patty Murphy (pxm491) (01/08/21 12:20 pm):** The proposed changes do not represent a significant departure from the approved curriculum and so will not require notification to or approval from SACSCOC.
