Department of International Studies, College of Arts and Sciences.

The Faculty Senate, at its April 21, 2021 meeting, had no objections to inactivate the Ph.D. in International Studies in the Department of International Studies for the College of Arts and Sciences. The program was established in 2013 in order to deal with the backlog of students who were in the program. No new students have been admitted since fall 2013. There are four students currently enrolled in the Ph.D. program: three are scheduled to graduate in spring 2021, and one was to be dismissed from the program. The three remaining students should complete the program by spring 2021.

The proposal is enclosed for your reference.

Reason for Closure

The College of Arts & Sciences is requesting to close the PhD in International Studies effective at the end of the Spring 2021 semester.

This interdisciplinary PhD program in International Studies, established through Faculty Senate Legislation 2013-07B, has not admitted any new students since Fall 2013, in order to deal with the backlog of students who were in the program. Retirements and departures of tenured faculty over the past seven years have resulted in a shortage of available faculty to manage the doctoral students while also teaching courses for the undergraduate major, one of the largest in the College. Further, the corresponding International Studies MA program has seen a reduction in student applications possibly indicating a shift in student interests to other existing or newly-established graduate programs within the College and the University.

Describe the number of students currently enrolled in the program and when they are expected to complete the program

There are four students currently enrolled in the INS PhD program: 3 are scheduled to graduate Spring 2021 and 1 will be dismissed from the program this week. No new students have been admitted since Fall 2013. All three students have completed their coursework and are in the dissertation stage of the program. All should complete the program by Spring 2021, otherwise they will have reached the limit of extensions and allowances to the Graduate School's Time to Completion policy.

Explain how current students will be helped to complete their program of study

Current faculty are engaged with these students as members of dissertation committees. The faculty will continue to do so until the students' scheduled completions in Spring 2021. If the request to close the program is approved for the end of Spring 2021, current students will not

Describe any additional charges/expenses students will incur due to the program closure, if any

N/A. As this is an interdisciplinary program, all departmental resources remain and no additional expenses due to program closure will be incurred.

Describe how current faculty and/or staff will be affected by the program closure, if at all, and how they will be redeployed or helped to find new employment.

N/A. All faculty in the interdisciplinary PhD program will maintain their primary appointments in their home departments. Graduate courses will continue to be offered to accommodate other graduate programs that include INS courses. In addition, INS faculty appointed to the Department of International Studies will continue to teach the 100+ undergraduate international studies majors and other Arts and Sciences students.

Explain how and when any affected parties (students, faculty, staff) will be informed of the impending closure

Faculty in the interdisciplinary program voted to close the PhD on 11/20/20. The program staff person was also present. As all students in the program are expected to graduate Spring 2021 (otherwise they will have exceeded all reasonable time for completion as defined by the Graduate School). Current students will be informed of the closure upon the approval of the College faculty. However, if the request to close the program is approved for the end of Spring 2021, current students will not be affected.
