This program provides provide students with an interest in both criminal justice and public administration an opportunity to obtain two degrees in an accelerated fashion.

Masters of Public Administration (MPA) program prepares public service officials in government and nonprofit organizations, as well as develops management skills essential to public and nonprofit organizations oriented towards a diverse metropolitan environment.

The M.S. in Criminology and Criminal Justice provides training in fundamentals of the criminal justice system and criminological theory, as well as foundational training in research methods and statistics.

The dual MPA/MSCCJ program requires a total of 60 credits, comprised of MPA and MSCCJ core courses, the 3-credit MPA Internship and the 6-credit MSCCJ Completion Track (either an internship with an accompanying paper, or a comprehensive exam and preparation, or Master's thesis).

Students may elect to combine their MPA Internship (400 hours) and MSCCJ Internship (300 hours, plus writing an internship research paper) into one year-long experience that combines elements of both programs with faculty approval.

Rationale

Rationale

The College of Arts & Sciences' Department of Political Science and Department of Sociology seek to offer a dual Master of Public Administration (MPA)/Master of Science in Criminology and Criminal Justice (MSCCJ) program. Both of these programs are successful professional degree programs within the College of Arts and Sciences, and both programs have a history of shared electives. There is strong interest, particularly from students interested in working in criminal justice administration and the security sector, to have a more formalized opportunity to be credentialed in the areas of administration, management, policy, and leadership, which are offered through the MPA program.

The MPA/MSCCJ dual degree is designed for students who seek an in-depth knowledge of both the spheres of policy, administration, and leadership as well as criminology and criminal justice. In addition to the professional advantage of studying public administration as part of UM's successful and highly regarded MPA program, students will benefit from the different perspectives on criminal justice and crime offered by the MSCCJ program, including coursework on the criminal justice system, crime, security and public policy, and theories in criminology and criminal justice. This dual program is unique in that is combines theory and practice in organization, management, and administration of criminal justice and crime and security across a variety of social science perspectives.

The proposed MPA/MSCCJ degree will provide students with an interest in both public administration and criminal justice and criminology an opportunity to obtain two degrees in an accelerated fashion. Both programs have an established reputation in providing career training and internship opportunities with local, state, and government agencies as well as the non-profit and private sectors. Additionally, there is a growing demand for individuals with skills in budgeting, human resources management, program planning, security management, and criminal justice administration and policy. A dual MPA/MSCCJ program would provide graduates with a well-rounded career basis to succeed in both criminal justice and public administration.

Additionally, other universities in Florida (e.g., Florida International University, Florida State University, University of Central Florida) offer dual degrees in Public Administration and Criminal Justice. Given the positioning of the University of Miami as one of the leaders in graduate education in the state, it is important for the University to provide an opportunity to earn this type of dual degree. Furthermore, Miami itself represents a unique setting for this type of graduate study and, most importantly, the community where expertise in both public administration and criminal justice is urgently needed. This dual degree program is another opportunity to highlight UM as synergistic center for educational innovation, entrepreneurship, and community engagement.

Market Demand

Dual degrees, such as the proposed MPA/MAIA degree, have become increasingly popular in today's graduate landscape. Dual degrees confer many educational, professional, financial, and time-saving benefits. Also, part of the appeal are the broad alumni networks and employment opportunities and the optimization of the students' investments of time and money.

Dual degree programs offer an interdisciplinary education that can both diversify and specialize students' training and knowledge. Students are drawn to the appeal of finding a niche career where they can combine knowledge from two disciplines and the option of establishing themselves as competitive candidates with qualifications in more than one area. *Idealist* notes that degree which combined human rights content knowledge and public policy training are among the most sought after for students pursuing a dual degree.

Graduates of the MPA and MSCCJ programs have gone on to occupy numerous positions in such prestigious placements as the United Nations, The Centers for Disease Control and Prevention, Miami-Dade law enforcement agencies, the AFL-CIO, the Federal Bureau of Investigation, the Central Intelligence Agency, Morgan Stanley, and the U.S. Congress.

Relationship to Other Programs

The MPA program at UM already offers dual degrees with other programs across the university including the Master of Public Health (MPH), Master of Arts in International Administration (MAIA), and Juris Doctorate (JD). This dual degree option will be jointly overseen by the closely-associated College of Arts & Sciences' Departments of Political Science and Sociology.

Relationship to Undergraduate and Professional Programs

Both the Department of Political Science (POL) and the Department of Sociology (SOC) offer undergraduate majors. POL has majors in political science and public administration. SOC offers majors in sociology and criminology. These majors could feed into this dual degree program. In addition, both the MPA and the MSCCJ work closely with the College's other professional master's degree programs, including the M.A. in International Adminstration, to engage in joint events, networking seminars, and the shared Interdisciplinary and Professional Graduate Student Organization (IPS-GSO).

As both of these degree programs already exist, no additional library resources are needed to support this program.

Laboratory Facilities, Equipment, and Space Available and Needed to Support the Program

As both of these degree programs already exist, no additional space or equipment is needed to support this program.

Other Resources Available or Needed to Support the Program

The MPA program is a member of the Network of Schools of Public Policy, Affairs, and Administration (NASPAA). Unlike Public Administration programs which are members of NASPAA, their official accreditation agency, there is no such analog for either criminology or sociology.

Curriculum

Program Curriculum

The dual MPA/MSCCJ degree will be administered by the College of Arts & Sciences' Department of Political Science and Department of Sociology. No curricular changes are expected and both the MPA program and the MS in Criminology and Criminal Justice are established graduate programs, able to handle this additional dual degree option without additional resources. As with students in the standalone MPA and MSCCJ programs, dual degree students will have access to all existing events, resources, seminars, and advising within the Departments of Political Science and Sociology.

The MPA program has a successful recruiting pipeline of variety of students including professional students from private and government organizations, and undergraduates from Political Science and Business. Similarly, MSCCJ, while still very new, has a record of attracting students from a wide range of undergraduate majors including Criminology, Criminal Justice, Sociology, and Political Science. Both MPA and MSCCJ programs have a history of attracting students from government sectors, including the military. The University of Miami is also a participant in the Yellow Ribbon GI Enhancement Program. This provision of the post-9/11 GI Bill helps cover the expenses for earning a Master's degree for qualifying service personnel from the U.S. Armed Forces. Additionally, the recent listing of the online MPA program as one of Successfulstudent.org's top 30 online MPA programs has enhanced the reputation and appeal of this already robust program.

Enrollment Projections

Given the larger course load of a dual degree program, we estimate 3-5 students enrolled at any given time.

Teaching or Research Assistants

As both of these programs are master's degree programs, no teaching or research assistantships will be available.

Administration

Program Administration

The dual MPA/MSCCJ degree will be administered by the College of Arts & Sciences' Department of Political Science and Department of Sociology. No additional staff will be needed.

Budget

Program Budget

The program is designed to be self-supporting through those tuition revenues returned to the MPA and MSCCJ programs. No new personnel will be needed to staff this degree. A maximum of six (6) graduate credits may be transferred into the program. Veterans may apply for Yellow Ribbon/GI Bill financial assistance through the Veterans Affairs office.
